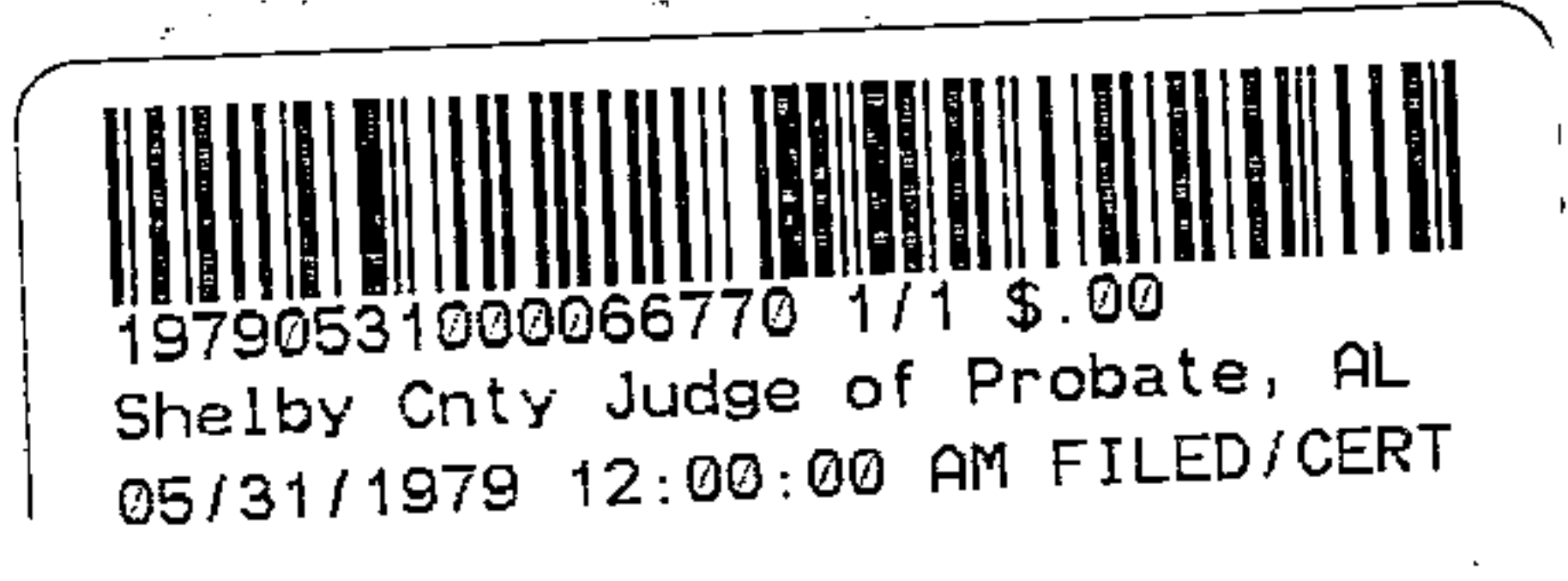


PARTIAL RELEASE FROM LIEN OF MORTGAGE

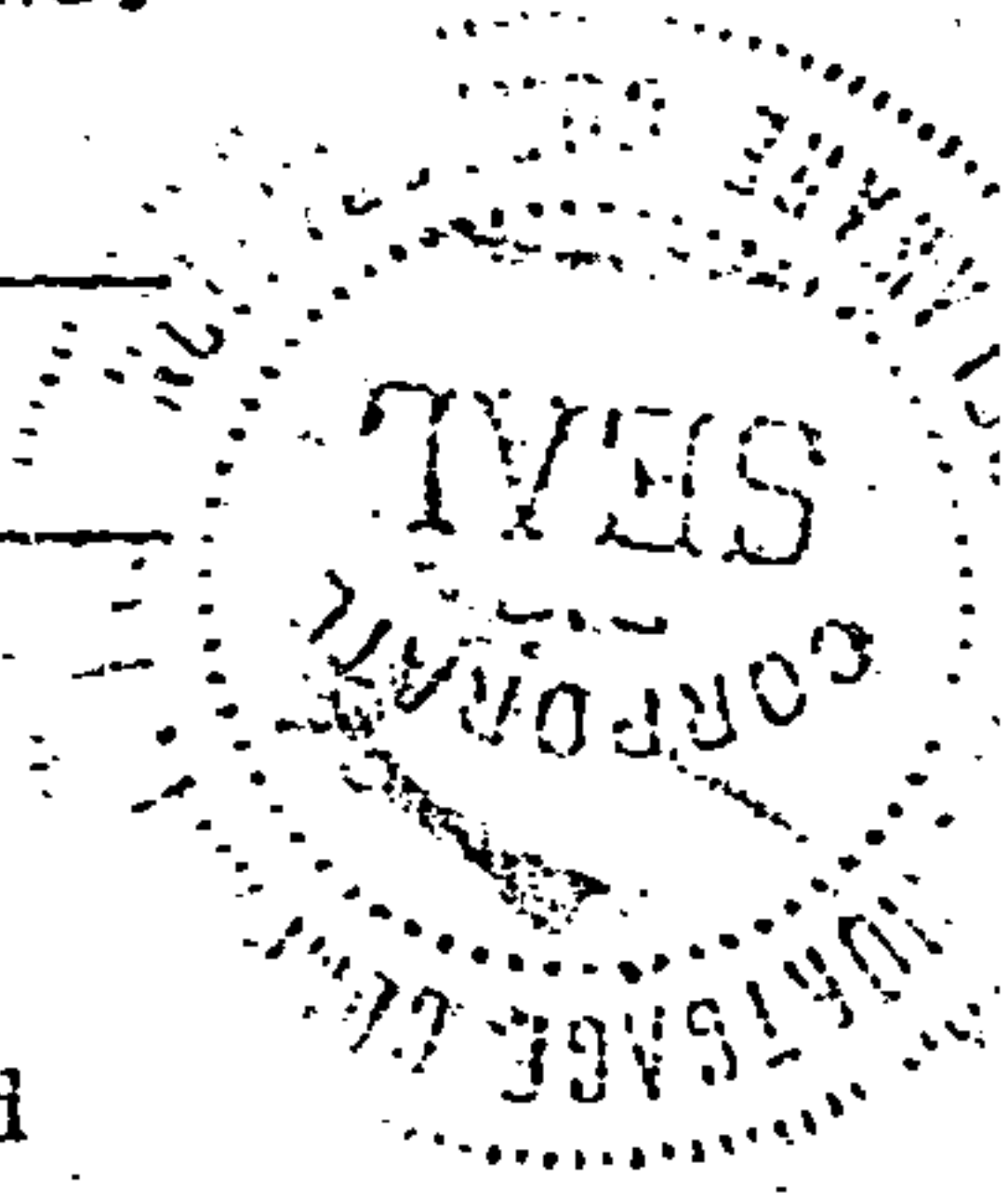
Lot 31, according to the survey of Shannon Glenm as recorded in Map Book 7, page 94, in the Probate Office of Shelby County Alabama.
