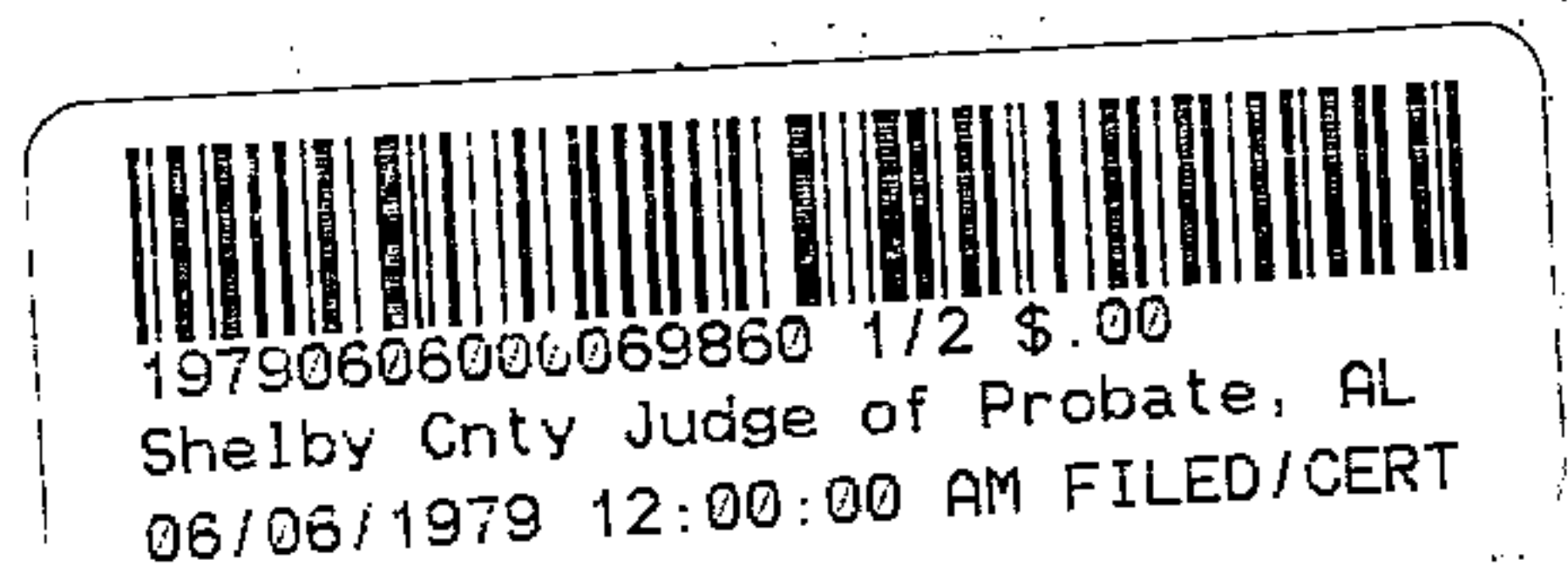


RELEASE OF MORTGAGES
