

hereby acknowledged, the undersigned CITY NATIONAL BANK OF BIRMINGHAM,  
A National Banking Association, does hereby release and discharge from  
the lien of that certain mortgage executed by Robert M. Roan and wife,

recorded in Volume 383, page 705, Probate Records of Jefferson

County, Alabama, the following described property:

Commence at the Northwest corner of the Northeast quarter of the Southwest quarter  
of Section 2, Township 21 South, Range 2 West, Shelby County, Alabama, thence Easterly  
along the North line of said quarter quarter section 1,160.20' to a point, Thence an  
angle of 43 degrees, 15 minutes 23 seconds to the right run Southeasterly 139.38' to  
the point of beginning of the property being described, thence continue along last des-  
cribed course 152.23' to a point, thence 43 degrees 15 minutes 23 seconds to the right  
28.12' to a point on the Westerly right of way line of a graveled public road, thence  
30 degrees 12 minutes 37 seconds right to tangent and along a curve having a central  
angle of 24 degrees 06 minutes and a radius of 442.14', an arc distance of 185.97' to  
the end of said curve, thence continue along tangent a distance of 26.87' to a point
