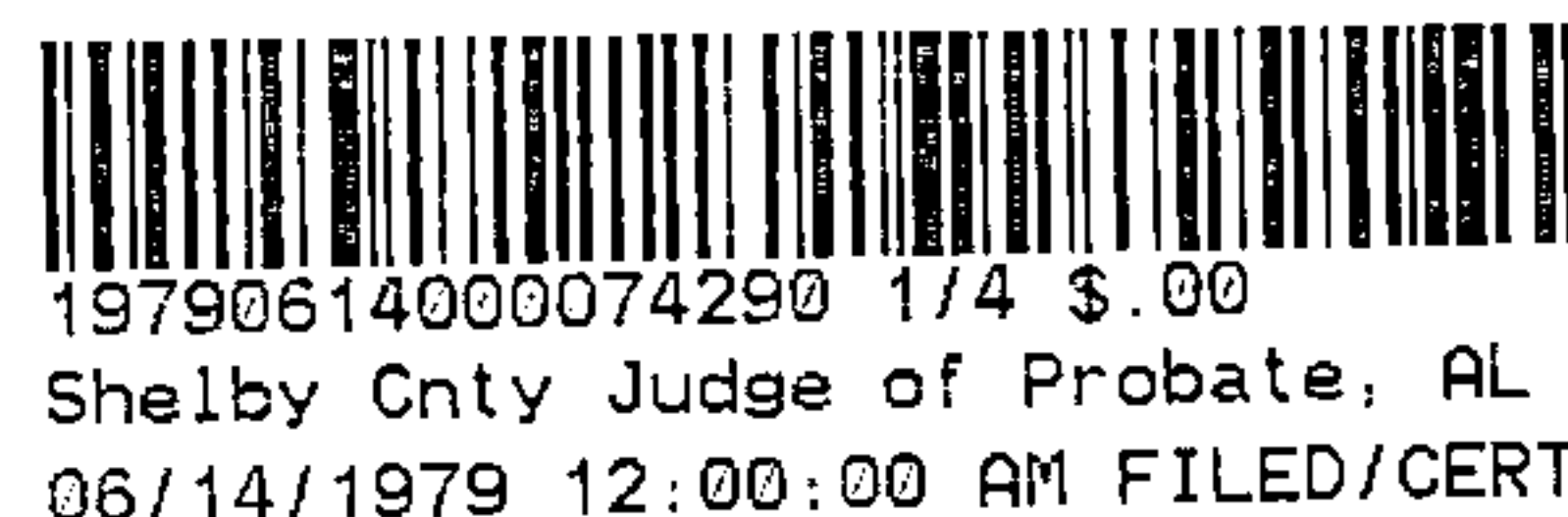

Begin at the intersection of the east line of Mill Street and the south line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 11, Township 21 South, Range 3 West, Shelby County, Alabama, and the south right-of-way line of South Avenue; thence east along the south line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section for 61.56 feet; thence 92 deg. 00 min. left and run northerly for 164.40 feet; thence 97 deg. 10 min. right and run southeasterly for 168.60 feet; thence 81 deg. 05 min. left and run northeasterly for 190.11 feet to the southeast corner of Lot 29, Siluria Mills; thence 106 deg. 36 min. left and run west along the south line of said Lot 29 for 154.54 feet to the southwest corner of said lot 29 and the northeast corner of Lot 10; thence 90 deg. 00 min. left and run southerly along the east line of said Lot 10 for 75.00 feet; thence 90 deg. 00 min. right and run westerly along the south line of said Lot 10 for 130.00 feet to the east right-of-way line of Mill Street; thence 90 deg. 00 min. left and run southerly along said east right-of-way line for 245.77 feet to the point of beginning.

Commence at the intersection of the west right-of-way line of Fallon Avenue and the south right-of-way line of Strowd Avenue, said right-of-way lines as shown on the Map of the Dedication of the Streets and Easements, Town of Siluria, Alabama; thence northwesterly along said right-of-way line of Strowd Avenue for 94.00 feet to the point of beginning; thence 90 deg. left and run southwesterly for 119.65 feet; thence 49 deg. 11 min. 22 sec. right and run southwesterly for 132.12 feet; thence 130 deg. 48 min. 38 sec. right and run northeasterly for 206.0 feet to a point on the south right-of-way line of Strowd Avenue; thence 90 deg. right and run southeasterly along said line of Strowd Avenue for 100.00 feet to the point of beginning.

Commence at the intersection of the north right-of-way line of Strowd Avenue and the west right-of-way line of Fallon Avenue, said right-of-way lines as shown on the Map of the Dedication of the Streets and Easements, Town of Siluria, Alabama; thence northwesterly along said right-of-way line of Strowd Avenue for 95.00 feet to the point of beginning; thence 90 deg. 09 min. right and run northeasterly for 100.36 feet; thence 27 deg. 13 min. 06 sec. left and run northwesterly for 77.92 feet; thence 62 deg. 42 min. 54 sec. left and run northwesterly for 68.00 feet; thence 90 deg. 04 min. left and run southwesterly for 170.0 feet to a point on the northerly right-of-way line of Strowd Avenue; thence 90 deg. 09 min. left and run southeasterly along said right-of-way line of Strowd Avenue for 103.64 feet to the point of beginning; being known as Lot No. 79 according to said map.

Begin at the intersection of the easterly right-of-way line of Mill Street and the southerly right-of-way line of 4th Avenue West, said right-of-way lines as shown on the Map of the Dedication of the Streets and Easements, Town of Siluria, Alabama; thence northeasterly along said right-of-way line of 4th Avenue West for 200.66 feet; thence 105 deg. 19 min. right and run southerly for 342.68 feet; thence 91 deg. 15 min. 45 sec. right and run westerly for 179.39 feet to a point on the easterly right-of-way line of Mill Street; thence 88 deg. 23 min. 45 sec. right and run northerly along said right-of-way line of Mill Street for 196.60 feet to the beginning of a curve to the left, said curve having a radius of 325.36 feet; thence continue northerly along said right-of-way line of Mill Street and along the arc of said curve for 90.36 feet to the point of beginning; being also known as Lot No. 18 according to said Map.
