DECREE

This cause coming on to be heard on Petition to Modify and the evidence being given orally in open court, and the cause being submitted and duly considered, the Court finds that the following decree should be and the same is hereby rendered:

- 8. Robert Dale White is hereby directed to pay the sum of \$2,250.00 to the firm of Stone, Patton & Kierce as attorney's fee for representation of Virginia Kaye White.
- 9. Robert Dale White is directed to perform all provisions of the Decrees of this Court dated August 23, 1978, and October 16, 1968, which have not heretofore been performed.
