Continue along the last described course for 90.00 feet, then turn an angle of 112 degrees 55 minutes 31 seconds to the right and run easterly 184.35 feet, then turn an angle of 80 degrees, 14 minutes 10 seconds to the right and run southerly for 84.11 feet, then turn an angle of 99 degrees 45 minutes 50 seconds to the right and run westerly for 163.56 feet back to the point of beginning.
