

Part of the SE% of NE%, Section 12, Township 21 South, Range 3 West, Shelby County Alabama, said part being more particularly described as follows: From the southeast corner of said SE $\frac{1}{4}$ of NE $\frac{1}{4}$, run north along the east line of said $\frac{1}{4}$ - $\frac{1}{4}$ section for a distance of 403.55 feet to the point of beginning of the property herein described; thence turn an angle to the left of 90deg. and run west for a distance of 190.61 feet; thence turn an angle to the right of 106 deg.33 min. and run northeasterly for a distance of 669.17 feet to a point on the east line of said SE% of NE% which is 641.45 feet north of the point of beginning; thence run south along said east line for a distance of 641.45 feet to the point of beginning; containing 1.40 acres, more or less.
