

(herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby

County, Alabama, to-wit:

One Thousand and no/100---

Part of the SE% of NE%, Section 12, Township 21 South, Range 3 West, Shelby County Alabama, said part being more particularly described as follows: From the southeast corner of said SE $\frac{1}{4}$  of NE $\frac{1}{4}$ , run north along the east line of said  $\frac{1}{4}$ - $\frac{1}{4}$  section for a distance of 403.55 feet to the point of beginning of the property herein described; thence turn an angle to the left of 90deg. and run west for a distance of 190.61 feet; thence turn an angle to the right of 106 deg.33 min. and run northeasterly for a distance of 669.17 feet to a point on the east line of said SE% of NE% which is 641.45 feet north of the point of beginning; thence run south along said east line for a distance of 641.45 feet to the point of beginning; containing 1.40 acres, more or less. ALSO, an easement 20 feet in width, for ingress and egress, situated in the SE½ of NE½ and in the NE¾of SE¼, both in said Section 12, Township 21 South, Range 3 West, said easement being more particularly described as follows: Beginning at the Northeast corner of said NE¼ of SE¼, run thence south along the east line of said  $\frac{1}{4}-\frac{1}{4}$  section for Ma distance of 156.0 feet; thence turn an angle to the right of 39 deg. 35 min. and run southwesterly for a distance of 445.68 feet to a point on the northeast \_\_right-of-way line of U.S. Highway 31, thence turn an angle to the right of ₹96 deg. 00 min. and run northwesterly along said highway right-of-way line for a distance of 20.11 feet; thence turn an angle to the right of 84 deg.00 min. and run northeasterly for a distance of 436.38 feet; thence turn an angle to the left of 39 deg. 35 min. and run north for a distance of 557.35 feet; thence turn an angle to the right of 90 deg and run east for a distance of 20  $\leq$  feet to a point on the east line of said  $SE_4$  of  $NE_4$ ; thence turn an angle Sto the right of 90 deg. and run south along said east line for a distance of 408.55 feet to the point of beginning.

This deed is executed for the purpose of correcting the erroneous description contained in that certain deed recorded in Deed Book 320, Page 541 in the Probate Office of Shelby County, Alabama.
