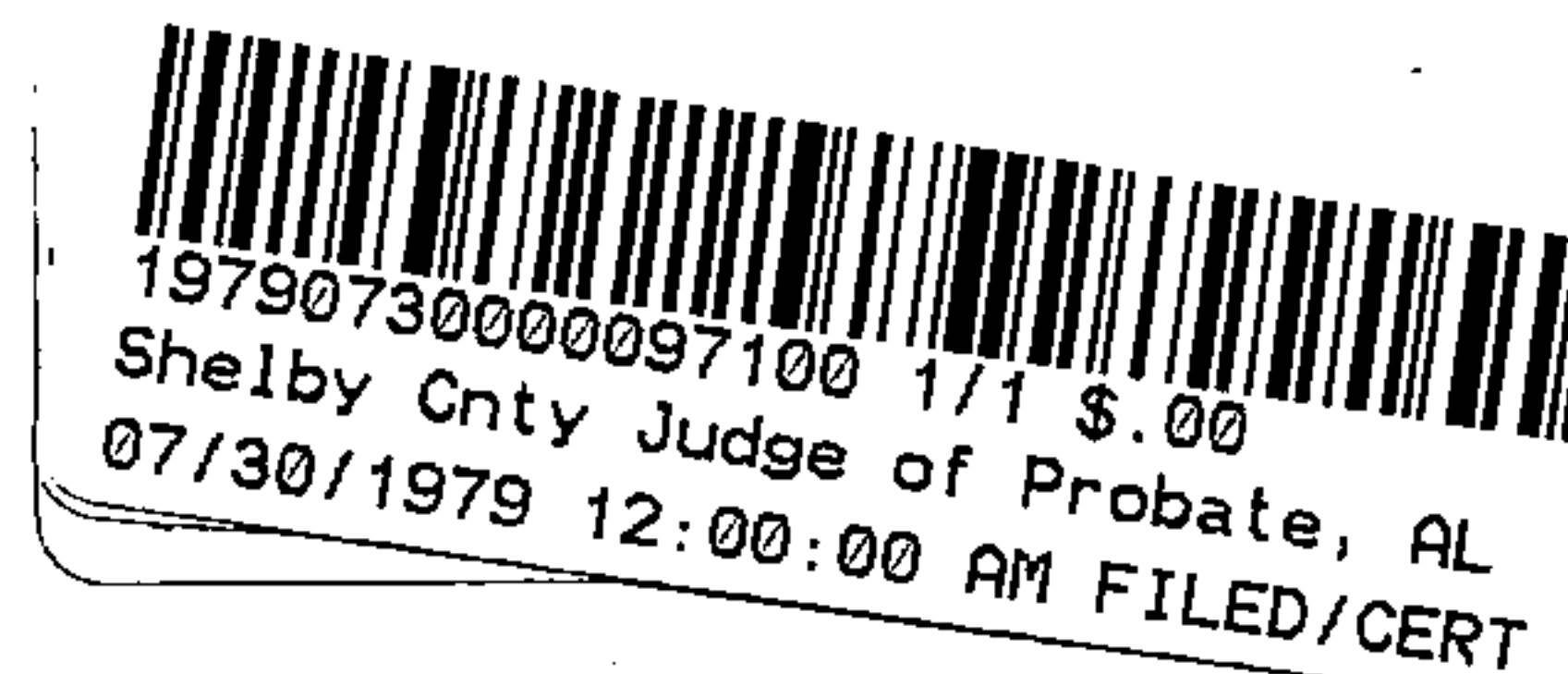


Satisfaction of Mortgage - Alabama

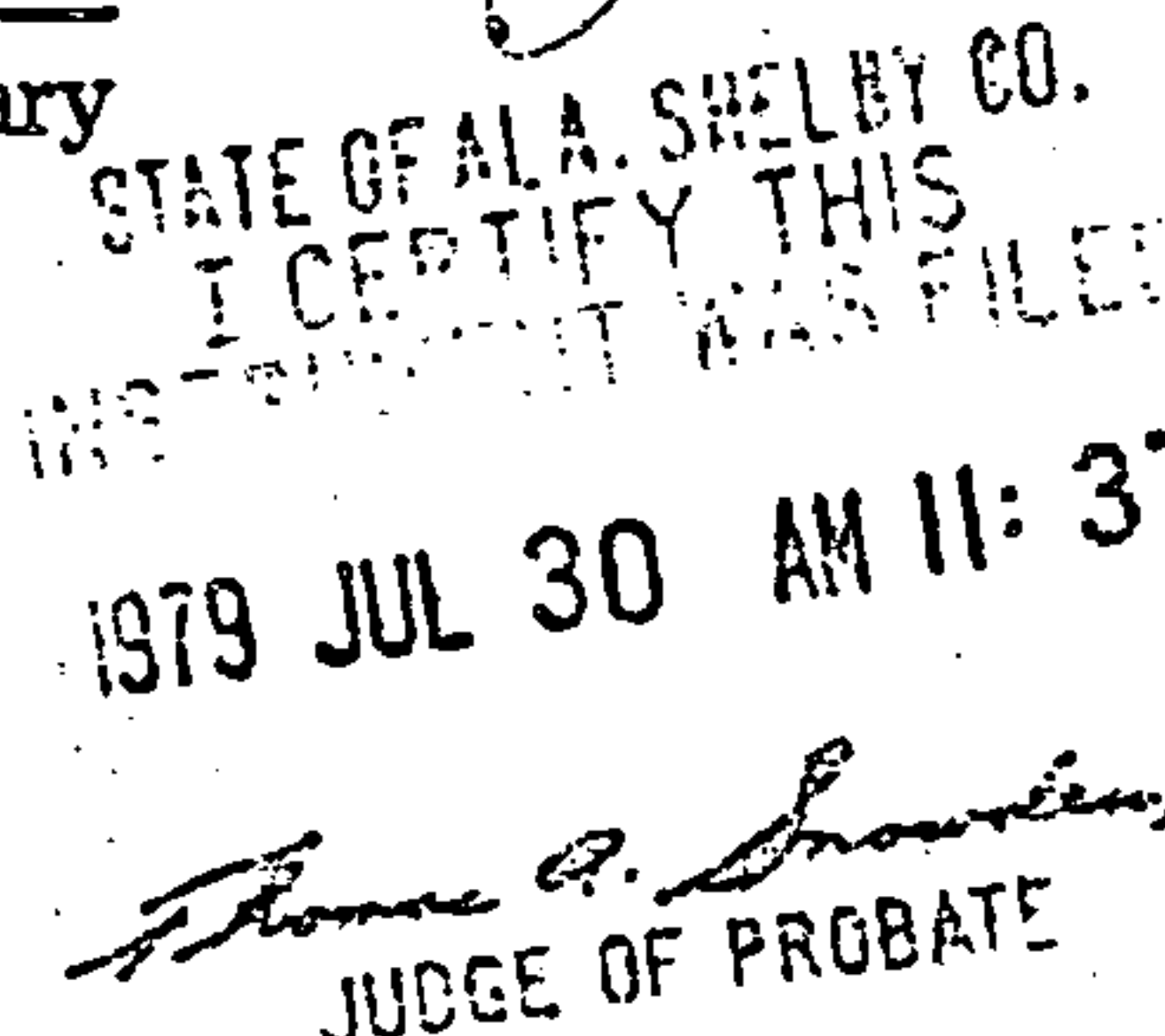
KNOW ALL MEN BY THESE PRESENTS that the undersigned, Mid State Homes, Inc.,
