

GRANT, BARGAIN, SELL and CONVEY unto the said WORLD WIDE JEWISH MISSIONS, a non-profit corporation, the following described real estate situated in Shelby County, Alabama, to-wit:

The NE 1/4 of SW 1/4 of NW 1/4 of Section 31,
Township 18 South, Range 1 West. Minerals
and mining rights excepted. Situated in
Shelby County, Alabama.

Parcel 2: A part of the NW 1/4 of SW 1/4 of NW 1/4 of Section 31, Township 18 South, Range 1 West, described as follows: Commencing at NE corner of said NW 1/4 of SW 1/4 of NW 1/4; thence Southerly direction along Eastern boundary of said 1/4-1/4-1/4 Section 73 feet more or less to a point on the southern boundary of a road, which is the point of beginning; thence turn an angle of 34 deg. 05' to right and proceed along said southern boundary of said road 250 feet; thence turn an angle of 107 deg. to left and run 146.75 feet, more or less to a point on Eastern Boundary of said 1/4-1/4-1/4 Section; thence turn an angle of 107 Deg. 05' to left and run Northerly along the eastern boundary of said 1/4-1/4-1/4 Section 250 feet more or less to point of beginning. The said premises hereby conveyed are subject to a mortgage thereof made by DOROTHY ELWELL MARDEN and husband VICTOR MARDEN to ROBERT L. SCHULTZ and LOTS J. - 3. The said conditions and convenants, and each and every one of them, are hereby expressly made an essential part of this instrument in respect to the said premises, and the parties herein designated, and their successors, heirs, and assigns.

TO HAVE AND TO HOLD, to the said WORLD WIDE JEWISH MISSIONS, a non-profit corporation, and its successors and assigns forever.

And we do, for ourselves, and for our heirs, executors, and administrators, convenant with the said WORLD WIDE JEWISH MISSIONS, a non-profit corporation, its successors and assigns, that we are lawfully saized in fee simple of said premises: that they are free from all encumbrances; except as above noted; that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall, warrant and defend the same to the said WORLD WIDE JEWISH MISSIONS, a non-profit corporation, and its successors and assigns forever, against the lawful claims of all persons.
