

KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of the sum of one dollar and 00/100 (\$1.00) cash in hand paid by THE RIVERCHASE SEWER DISTRICT, the receipt whereof is hereby acknowledged, we, the undersigned, do hereby grant, bargain, sell and convey unto the said RIVERCHASE SEWER DISTRICT, its successors and assigns, a right-of-way for ingress and egress for sanitary sewer maintenance purposes, said right-of-way being 20 feet in width or 10 feet on each side of a center line located and described as follows, to-wit:

Commence at the N.E. corner of the N.E. 4 of the S.E. ½ of Section 19, Township 19 South, Range 2 West, Shelby County, Alabama, and run west along the north line of said \(\frac{1}{4} - \frac{1}{4} \) section 4622.16 feet to a point; thence 90° 00' to the left and run southerly 88.78 feet to a point; thence 590 17' 35" to the right and run southwesterly 364.98 feet to a point; thence 40 20' to the right and run southwesterly 39.10 feet to a point; thence 83° 58' to the left and run southeasterly 13.85 feet to the point of beginning, said point being a manhole at station 7+08 on an existing 30 inch sanitary sewer; thence 37° 25' 45" to the left and run southeasterly 85.30 feet to a point thence 0° 50' to the left and run southeasterly 70.61 feet to a point; ' thence 66° 45' to the left and run northeasterly 99.38 feet to the point of ending, lying and being in Shelby County, Alabama.

For the consideration aforesaid, the undersigned do grant, and convey unto the said RIVERCHASE SEWER DISTRICT, the right and privilege of ingress and egress from said strip and the right to cut and keep clear all trees, undergrowth and other obstructions on the lands of the undersigned adjacent to said strip when deemed reasonably necessary for the avoidance of danger in and about said use of said strip, and the right to prohibit the construction or maintenance of any improvement or obstruction (except fencing) on, over, across or upon said area herein conveyed.

In consideration of the benefit of the property of the undersigned by reason of the construction of said sewer, the undersigned hereby release RIVERCHASE SEWER DISTRICT, the State of Alabama, and/or the United States of America, and/or any of their agents, from all damages present or prospective to the property of the undersigned, arising or resulting from the construction, maintenance and repair of said sewer; and the undersigned do hereby admit and acknowledge

that said sewer if and when constructed will be a benefit to the property of the undersigned.
