KNOW ALL MEN BY THESE PRESENTS, that I, Virginia Durr,
of the City of W. Tuscaloosa, State of Alabama,
have made, constituted and appointed and by these presents do make,
constitute and appoint John W. Durr of the City of Montgomery,
State of Alabama, as my true and lawful attorney for me and in my
individual name, place and stead, giving and granting to him as he
shall deem advisable, the full, complete and unlimited right, power
and authority to negotiate for and lease to Atlantic Richfield
Company, its agents, employees, successors or assigns, all those
lands that are a part of the Estate of Jno W. Durr a/k/a John W.
or J. W. Durr. I give to John W. Durr, as my true and lawful
attorney in fact for me and in my name, place and stead, with the
unlimited right, power and authority, including, but not limited
to the following powers:

 3. To borrow money in such amounts and on such terms as he
may deem best from time to time, and to give security therefor and
notes evidencing the indebtedness, and to pay the same from any
funds of the undersigned; and to generally contract and handle any
