RESTRICTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS, THAT
WEEREAS, the undersigned owners of record of the following described real estate inShelby

Subdivision as shown on the plat recorded in Map Book, Page, in the Office of the Judge of Probate County, Alabama; and
WHEREAS, the said undersigned owners are desirous of establishing or placing the heretofore described subdivision under certainties covenants to insure the use of the property for attractive residential purposes and thereby to secure to each site owners.
NOW, THEREFORE, the undersigned owners do hereby adopt the following conditions, restrictions, covenants and limitation which shall apply in their entirety to all lots in the said Subdivision and shall be included as a part of the consideration in training and conveying title to any or all of said lots in said subdivision:  1.
