KNOW ALL MEN BY THESE PRESENTS, that Thorp Consumer Discount Company, a Pennsylvania corporation; successor by merger to Thorp Discount, Inc., a Delaware corporation which was previously authorized to do business in the State of Alabama, formerly known as Aetna Discount Company; successor by merger to (1) Aetna Discount Co., an Alabama corporation; and (2) Aetna Discount Co. of Alabama, an Alabama corporation, has made, constituted and appointed, and by these presents does make, constitute and appoint David E. Plante as its true and lawful attorney-in-fact for said Corporation and in its name, place and stead to release any mortgage or mortgages of record in the State of Alabama and the various counties therein in which any of the above corporations appears as mortgagee, and to acknowledge satisfaction and to discharge the same fully, or as to certain lands therein described, giving said attorney-in-fact full power to do everything whatsoever requisite and necessary to be done in the premises, hereby ratifying and confirming all that said attorney-in-fact so appointed shall lawfully do or cause to be done by virtue hereof. This Power of Attorney and the authority herein shall expire and be null and void three (3) years from the date hereof.

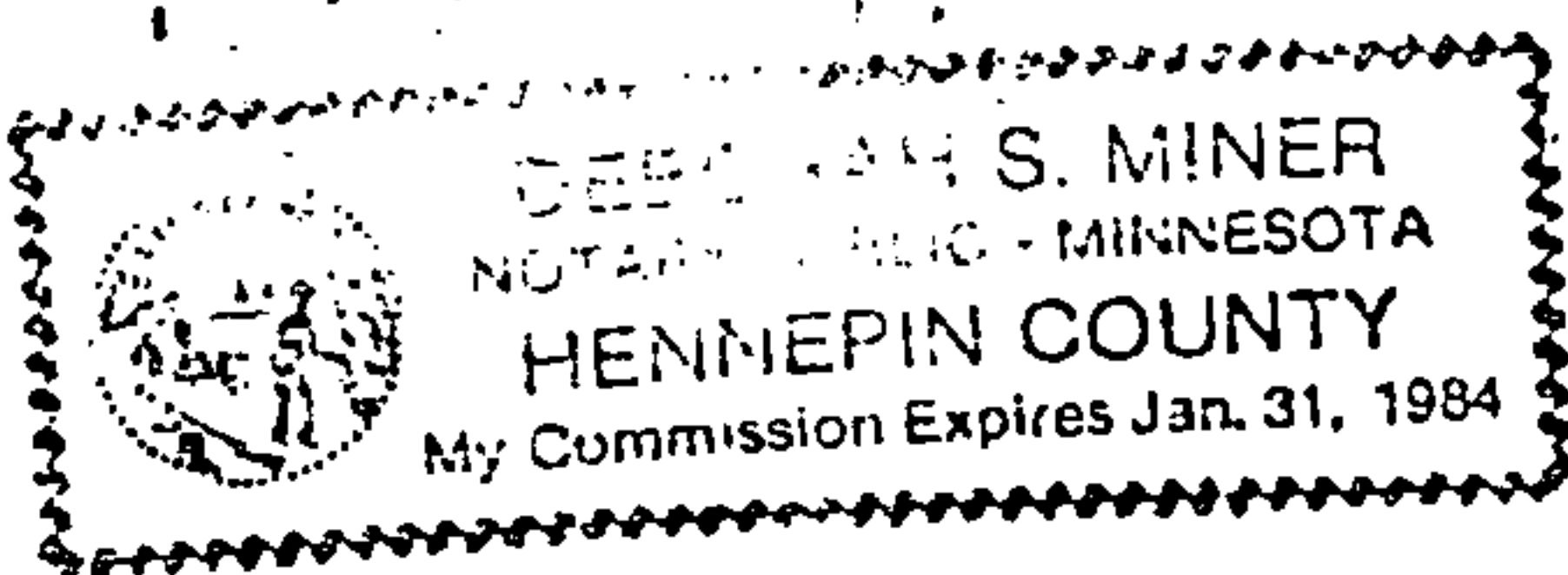
