A lot of land situated in the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ and in NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 3, Township 24 North, Range 12 East, being more particularly described as follows: Commence at the southwest corner of SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section 3 and run south 88 deg. 34 min. East 349.32 feet to the point of beginning of the parcel herein described; from said point of beginning run north 8 deg. 53 min. West 296.0 feet to the south right-of-way line of Highway No. 25; run thence south 72 deg. 39 min. west along said highway right-of-way 201.0 feet to the east line of the L. A. Battle property; run thence south 10 deg. 24 min. East along the East line of L. A. Battle property 260.33 feet; run thence 87 deg. 45 min. East 29.70 feet; run thence south 6 deg. East 130.5 feet; run thence (north) 87 deg. 05 min. East along a fence 227.5 feet; run thence north along a fence 172 feet; run thence south 74 deg. 20 min. 




