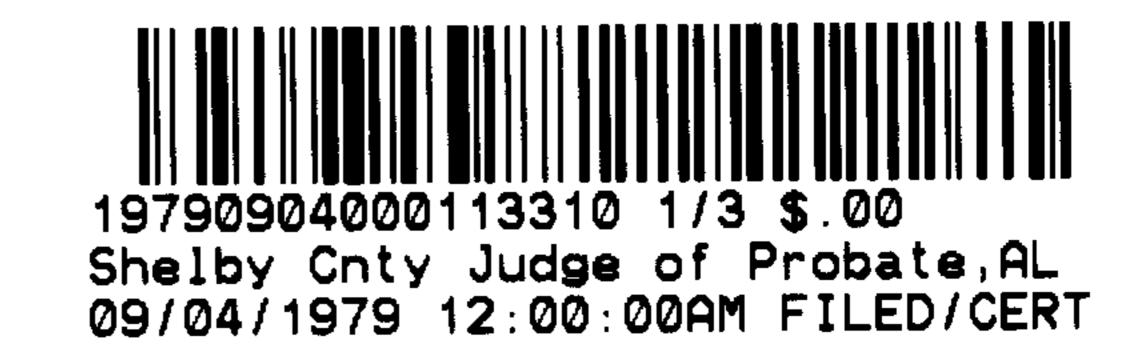

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of Twenty-Six Thousand Eight Hundred Twenty-Seven and 30/100 (\$26,827.30) Dollars, to the undersigned grantors, JOHN T. BATSON, a single man, JAMES L. BATSON, III and wife, MARIE BATSON, JAMES L. BATSON, JR., and wife, ELIZABETH SMITH BATSON, in hand paid by Kimberly-Clark Corporation, the receipt whereof is hereby acknowledged, we, the said John T. Batson, James L. Batson, III, Marie Batson, James L. Batson, Jr. and Elizabeth Smith Batson, do hereby grant, bargain, sell and convey unto the said Kimberly-Clark Corporation, all pine and hardwood sawtimber and pulpwood except 18 pine seed trees marked with yellow paint, and except all timber in the creek bottom of Four Mile Creek which is located within an area that is flagged, located in the S^{1}_{2} of the SE^{1}_{4} , Section 25, Township 20 South, Range 1 East, Shelby County, Alabama. Also, all marked pine timber ्र in the NE% of NE% of Section 36, Township 20 South, Range 1 East, located between the J.L. Batson house and Four Mile Creek. Said property being situated in Shelby County, Alabama. Together with full and free right of ingress and egress to and from said land at any and all times until the expiration of eighteen (18) months from the date of the execution of this deed, for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantor herein.

It is understood and agreed that no line trees shall be cut. The grantee is hereby given the right to use existing private roads and has the right to build such temporary roads and other devises as may be necessary or useful to the grantee for the purpose of cutting and removing the timber, however, all roads are to be left in as good condition as at the beginning of this contract.

And we do for ourselves and for our heirs, executors and assigns, that we are lawfully seized of said premises in fee simple; that it is free from all encumbrances and we have a good right to sell and convey said timber as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Kimberly-Clark Corporation, its successors and assigns against the lawful claims of all persons.
