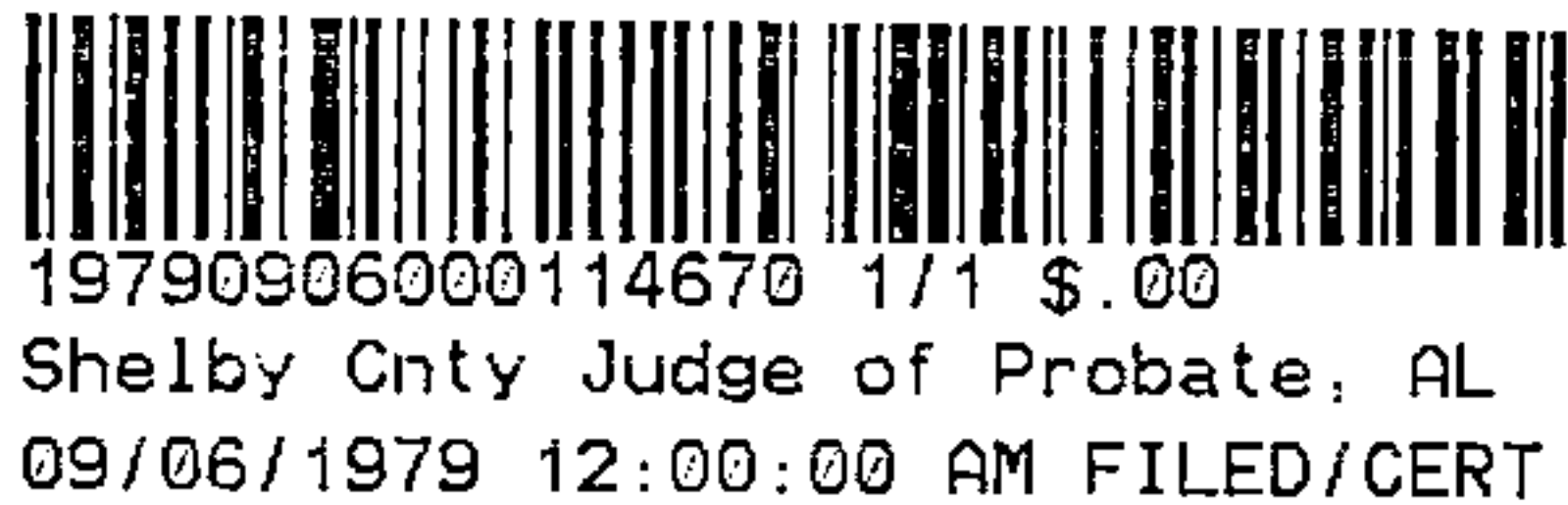


KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the payment of
