

For and in consideration of the Sum of One Dollar, the undersigned Anniston Production Credit Association, a Corporation, does hereby Release from that certain mortgage heretofore executed by Phillip D. Weldon and wife, Andrea W. Weldon and John K, Whitfield and wife, Louise G. Whitfield, recorded in Volume 391, Pages 926, 927 and 928 inclusive of the mortgage records of the Judge of Probate, Shelby County, Alabama, the following described Real Property:

Said property is more particularly described as follows: Commence at the Northeast (NE) corner of the Northeast (NE) Quarter (4) of the Southeast (SE) Quarter (4), of Section 33, Township 18 South, Range 2 East, Shelby County, Alabama, and run in a Westerly a distance of 1258.90 feet to a point; thence deflect 90 degrees 00 minutes 00 seconds to the left and run in a Southerly direction a distance of 667.28 feet to a point on the East right-of-way line of a county road, which point is the point of beginning; thence deflect 77 degrees 03 minutes 00 seconds to the left and run in a Southeasterly direction a distance of 290.00 feet to a point; thence turn an interior angle of 90 degrees 00 minutes 00 seconds and run to the right in a Southwesterly direction a distance of 150.00 feet to a point; thence turn an interior angle of 90 degrees 00 minutes 00 seconds and run to the right in a Northwesterly direction a distance of 290.00 feet to a point on the East right-of-way line of said county road; thence turn an interior angle of 95 degrees 41 minutes 30 seconds to the tangent of a curve to the right, having a radius of 756.20 feet, a central angle of 11 degrees 23 minutes 00 seconds, and an arc length of 150.25 feet, and run to the right in a Northeasterly direction along said right-of-way line a distance of 150.25 feet to the point of beginning of the herein described parcel; containing 1.01 acres, more or less.

It being distinctly understood that all the other terms and provisions and the other property described in said above described mortgage shall remain in full force and effect. This instrument shall not be construed to release any property other than the above described Real Property from said mortgage.
