TO HAVE AND TO HOLD unto said GATE CITY SAVINGS AND LOAN ASSOCIATION its successors and assigns forever.

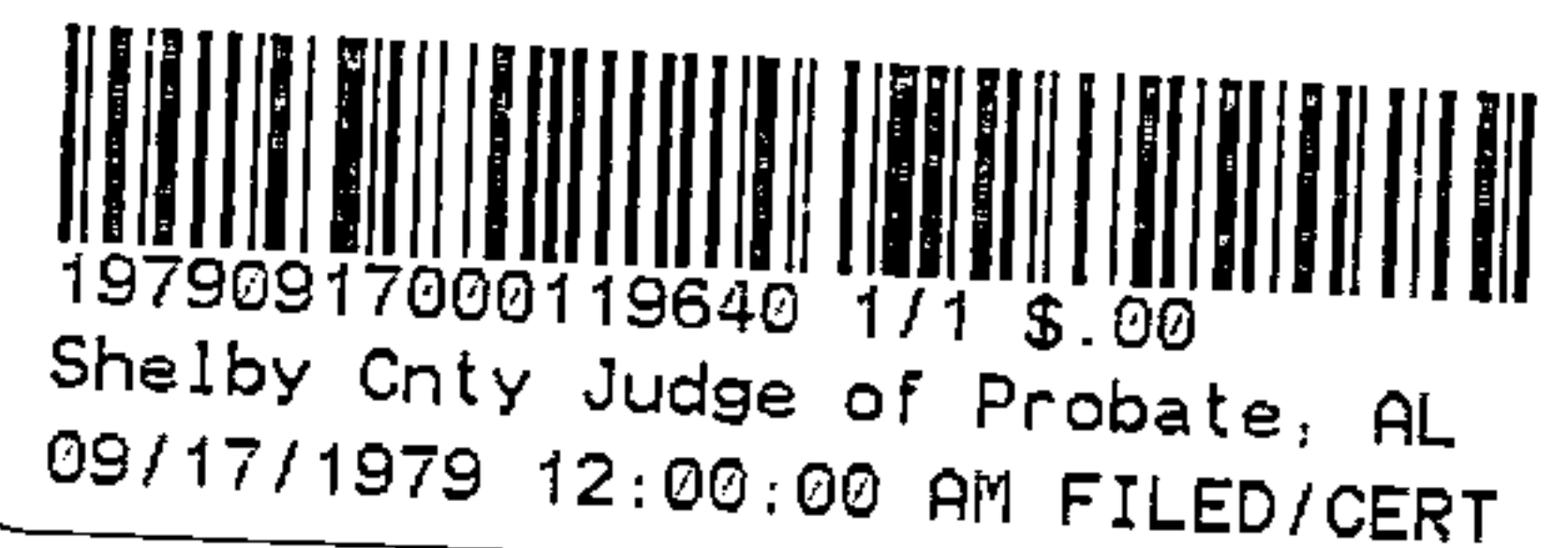
