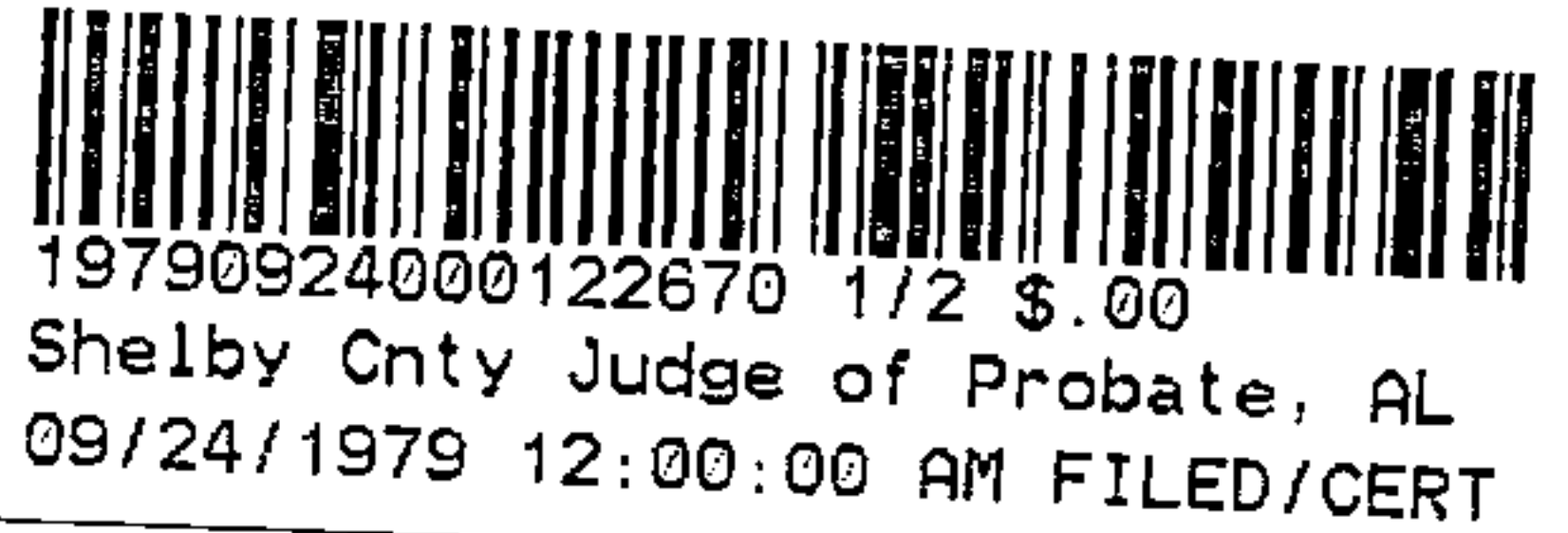

KNOW ALL MEN BY THESE PRESENTS, that whereas Otis D. Baker,  
plaintiff recovered judgement against M. W.  
Pearson on the 7th day of March, 1975, in the Civil Court of  
Jefferson County, Alabama in the amount of \$ 800.00 + \$18.05, cost,  
a certificate of said judgement being recorded in J.B. M, page 223  
Probate Office of Shelby County, Alabama wherein J. Thomas King  
was attorney for plaintiff.

NOW, THEREFORE, IN CONSIDERATION of the payment of \$ 409.03  
the receipt whereof is hereby acknowledged, the undersigned, as attorney for  
the plaintiff does hereby release from the lien and operation of said judgement  
the following described real estate, to-wit:

A parcel of land containing 7.73 acres located in the west  
 $\frac{1}{2}$  of the N.W.  $\frac{1}{4}$  of the N.W.  $\frac{1}{4}$  of Section 25, Township 20 South,  
Range 4 West, Shelby County, Alabama; described as follows:  
Commence at the Northwest Corner of said Sec. 25; Thence run  
South along the west section line a dist. of 666.0 feet to the  
point of beginning; Thence turn left  $92^{\circ} 09'$  and run east a  
dist. of 370.67 feet; thence turn right  $54^{\circ} 10'$  and run south-  
easterly a dist. of 334.84 feet to a point on the northwesterly  
right-of-way of Shelby County highway #13; Thence turn right  
 $71^{\circ} 32'$  and run southwesterly along said right-of-way a dist.  
of 298.0 feet to the point of a curve to the right having a  
Delta angle of  $23^{\circ} 25\frac{1}{4}'$  and a radius of 1352.69 feet; Thence  
follow arc of said curve a distance of 602.0 feet to a point on  
the west line of said Sec. 25; Thence turn right and run north  
along said west sec. line a dist. of 892.47 feet to the point of  
beginning.

This partial release shall not in any way impair or affect the right of the  
judgement creditor to hold any other property now owned or hereafter acquired by  
the said M. W. Pearson as security for the balance of said judgement remaining  
unpaid.

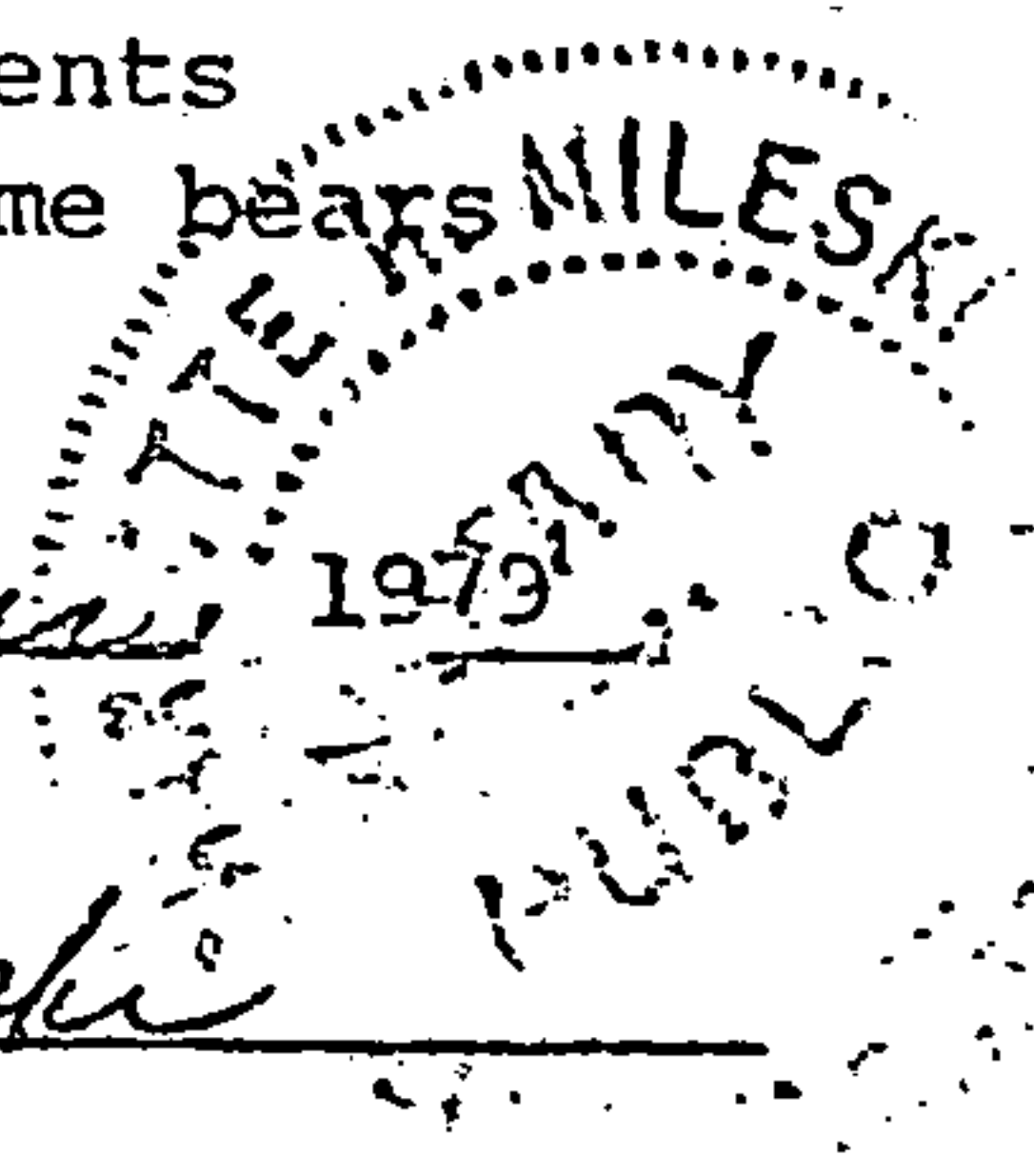

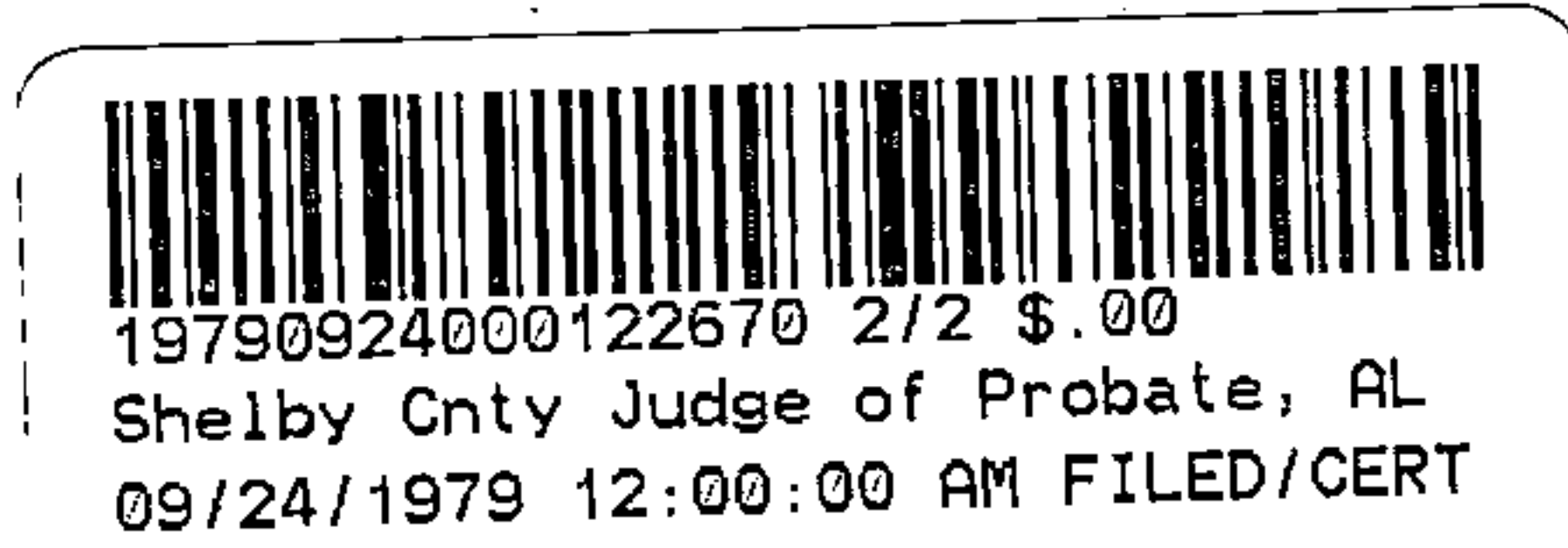
