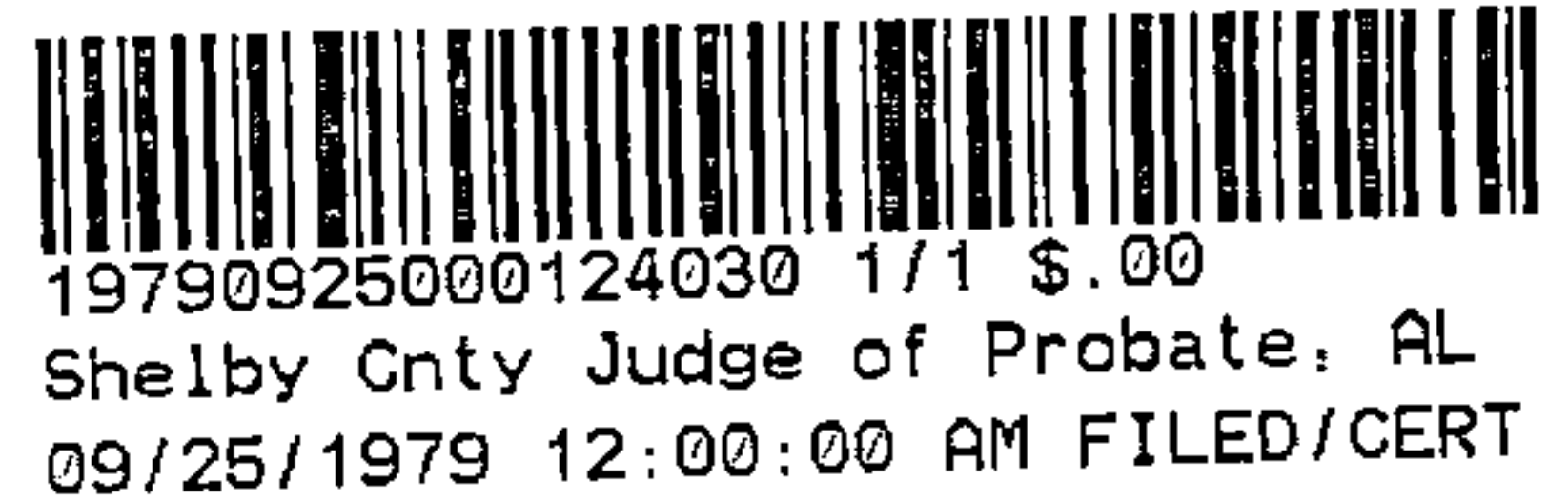


TRANSFER OF MORTGAGE
