CORRECTED STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS That for and in consideration of the sum of Ten and No/100 (\$10.00) dollars, cash in hand paid by Mrs. Wilma N. Scott to Mrs. Wilma N. Scott and Birmingham Trust National Bank as Co-Trustees of a Marital Trust under the will of George L. Scott, deceased, the receipt of which is hereby acknowledged, the said Wilma N. Scott and Birmingham Trust National Bank as Co-Trustees of a Marital Trust under the will of George L. Scott, deceased, do hereby grant, bargain, sell, and convey unto the said Wilma N. Scott, the following described real estate situated in Shelby County, Alabama, to-wit:

The North three-fourths of the NW $\frac{1}{2}$ of the SW $\frac{1}{2}$ of Section 35, Township 20 South, Range 3 West, excepting the right of way of 12th Street, NW as now located. Also a part of the NE $\frac{1}{4}$ of the SW $\frac{1}{2}$ of Section 35, Township 20S, Range 3W; more particularly described as follows: begin at the Northwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{2}$ of Section 35, Township 20S, Range 3W; thence run Southerly along the West boundary line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section for 993.67 feet; thence turn an angle of 88 degrees, 48 minutes, 36 $\frac{1}{2}$ seconds to the left and run Easterly 39.5 feet, more or less, to a point on the West right of way line of a County Road; thence run Northerly along the West right of way line of said County Road 994 feet, more or less, to the point of intersection of the West right of way line of said County Road and the North boundary line of the NE $\frac{1}{4}$ of the SW $\frac{1}{2}$ of Section 35, Township 20S, Range 3W, thence run Westerly along the North boundary line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section for 57.0 feet, more or less, to the point of beginning, and being 1.106 acres, more or less.

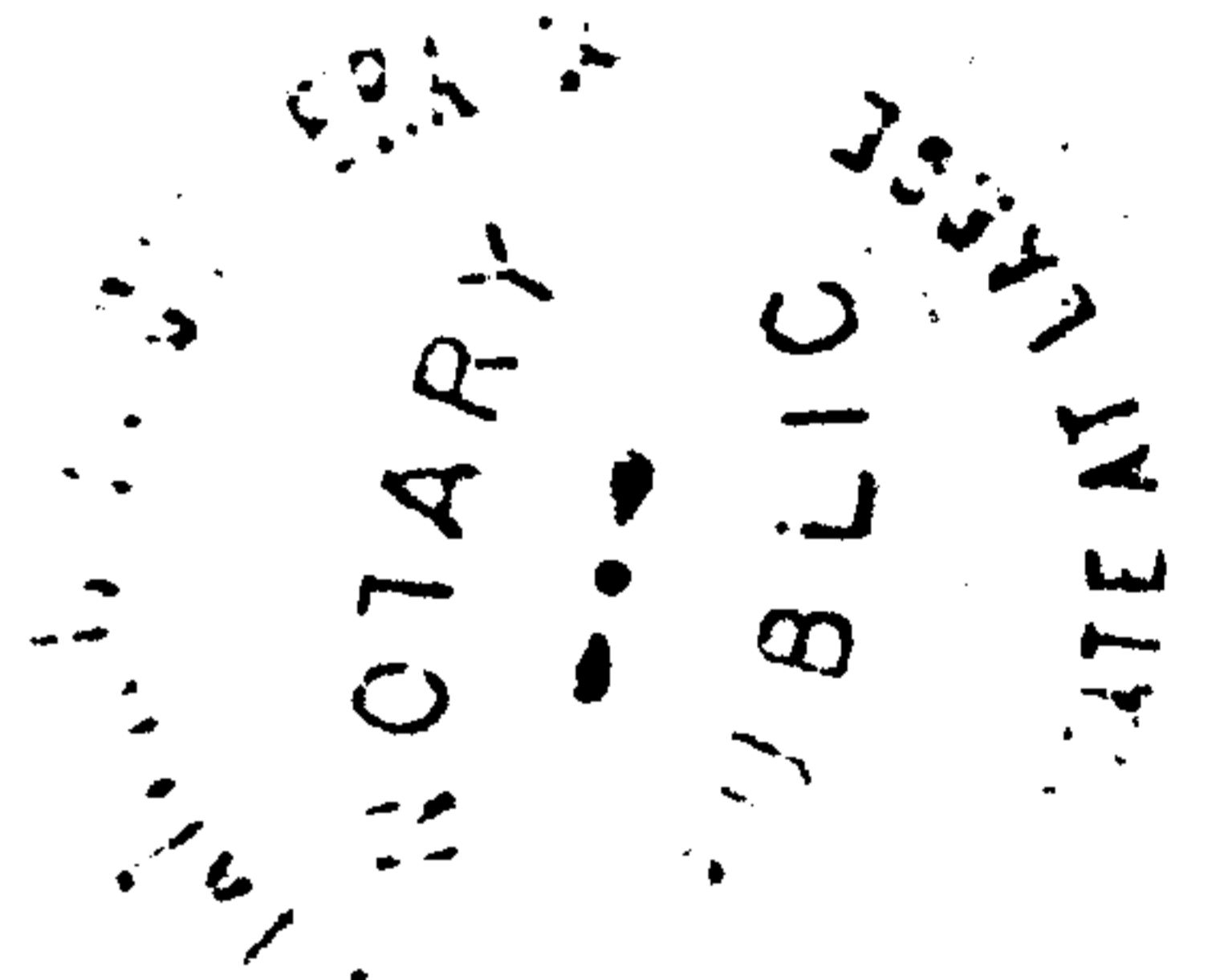
