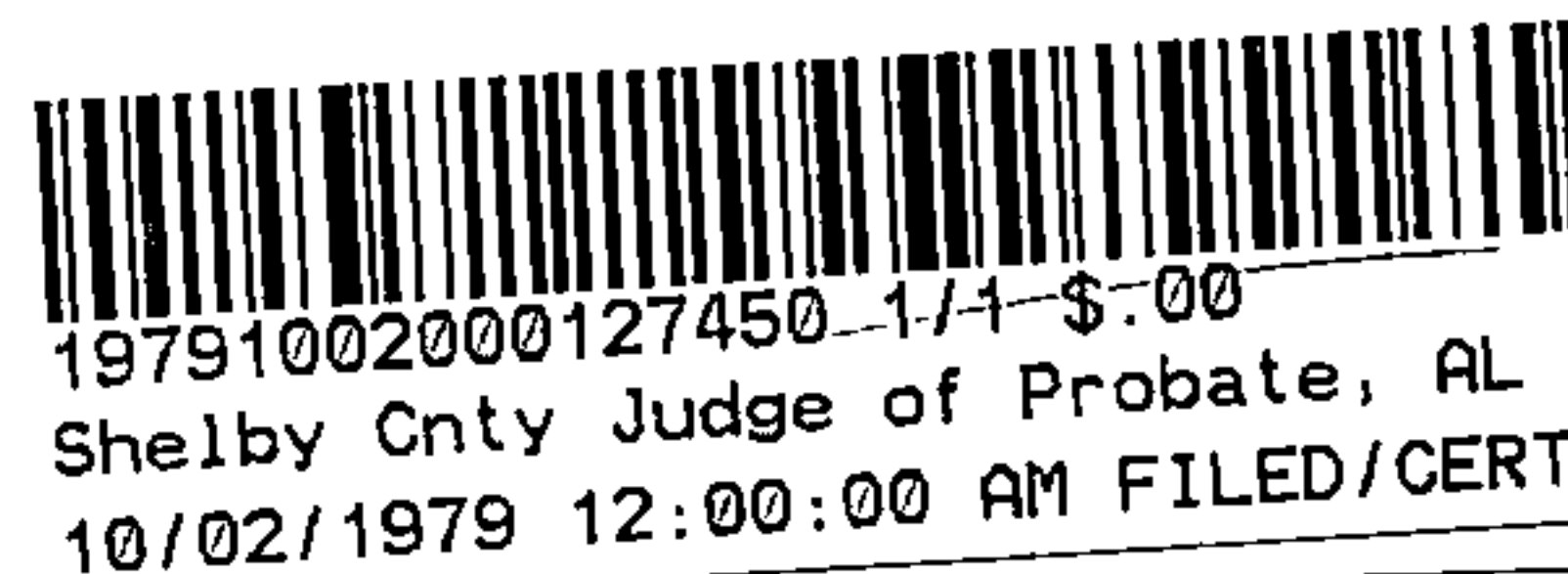

To reach a point of beginning commence at the NE corner of the SW 1/4 of the NE 1/4 of Sec. 31, Township 19 South, Range 2 West; thence run West along the North line of said SW 1/4 of the NE 1/4 a distance of 435.96 feet; thence turn an angle of 99 deg. 01' left and run a distance of 175.0 feet; thence turn an angle of 66 deg. 00' right and run a distance of 474.93 feet; thence turn an angle of 95 deg. 00' left and run a distance of 442.7 feet to the point of beginning of said plot of land herein described; thence from said point of beginning continue to run along the last described course a distance of 101.15 feet; thence turn an angle of 74 deg. 47' left and run a distance of 84.5 feet; thence turn an angle of 37 deg. 34' right and run a distance of 115.95 feet; thence turn an angle of 108 deg. 20' left and run a distance of 305.71 feet; thence turn an angle of 86 deg. 32' left and run a distance of 208.0 feet; thence turn an angle of 86 deg. 32' right and run a distance of 26.0 feet; thence turn an angle of 119 deg. 11' left and run a distance of 175.9 feet to the point of beginning of said plot of land.
