EASEMENT LOCATION AGREEMENT

WHEREAS, Mead Land Services, Inc., a corporation, (hereinafter called MLS) did heretofore convey certain real estate situated in Shelby County, Alabama, to H. E. Wills and wife, Marie M. Wills (hereinafter called Wills) by deed recorded in Deed Book 287 at page 307 in the Office of the Judge of Probate of Shelby County, Alabama (hereinafter called Deed); and

WHEREAS, James Andrew Braasch (hereinafter called Braasch) subsequently obtained title to a portion of said real estate, which portion is described as follows:

The N 1/2 of the NE 1/4 of the SW 1/4 of Section 5, Township 21 South, Range 2 West, Shelby County, Alabama. Minerals and mining rights excepted. (hereinafter called Real Estate)

through mesne conveyances from the Wills; and

whereas, MLS reserved and excepted a sixty-foot-wide non-exclusive right of way and easement for a road over and across all of the real estate conveyed by MLS to the Wills by the Deed, and as a part of said conveyance provided that said road was to be located by mutual agreement between MLS and the Wills or the Wills' heirs and assigns, surveyed, and a map or plat of said survey placed on record, all as contained in the Deed; and

WHEREAS, said sixty-foot-wide non-exclusive right of way and easement for a road or roads over and across the Real Estate (hereinafter called Roads) has now been located by mutual agreement between MLS and Braasch and his wife, Fran Sharpe Braasch (hereinafter jointly called Braaschs); and

WHEREAS, a map or plat of the Roads has been prepared by James H. Seale, Registered Land Surveyor of the State of Alabama, the same being dated May 26, 1979, a copy of said map

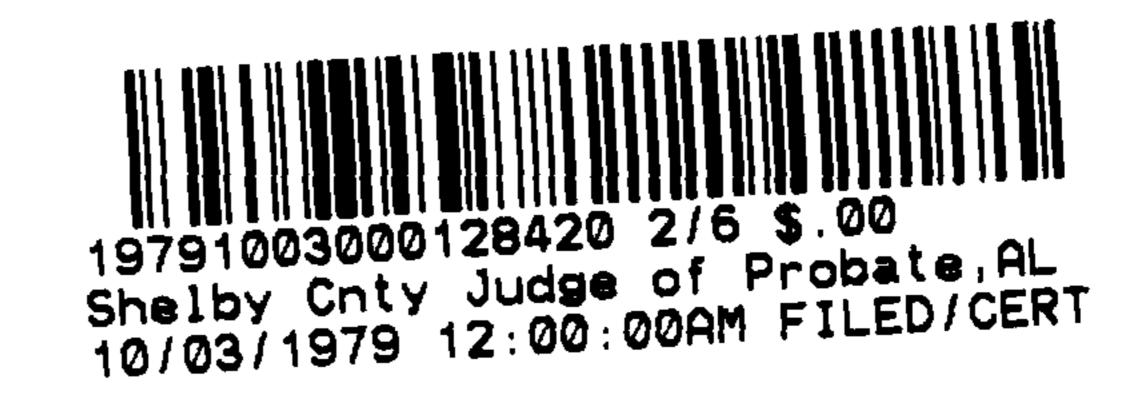

NOW, THEREFORE, in consideration of the premises, and in fulfillment of the provisions of the Deed and in further consideration of the mutual benefits accruing to MLS and the Braaschs, the sufficiency thereof being acknowledged by MLS and the Braaschs, MLS and the Braaschs do now mutually agree as follows:

- 1. The location of the non-exclusive right of way and easement for a road which was reserved by MLS in the Deed shall be the roads shown and described on Exhibit "A" and marked "Road 1" and "Road 2".
- 2. The locations of the Roads having been agreed upon by the parties hereto, MLS claims no right, title, easement, or encumbrance on or against the Real Estate except its rights to use the Roads and to dedicate either or both of them to Shelby County, Alabama or to any other appropriate governmental body, all as provided for hereinafter and in the Deed.
- 3. Either MLS or Braasch or their respective heirs, successors or assigns, shall have the right hereafter to convey or dedicate either or both of the Roads, or any part thereof, to Shelby County, Alabama, or to any other appropriate governmental body, as provided by the Deed. If either party wishes to dedicate either or both of the Roads, or any part thereof, the other party hereby agrees to cooperate in connection with such dedication and to execute any and all documents which may be necessary in connection with such dedication.
- 4. Neither MLS nor the Braaschs shall have any obligation to grade, pave or otherwise improve the Roads, but either party may do so, provided such work is done in accordance with the standards and requirements of Shelby County so that

Shelby County will accept the dedication of the Roads. The cost of such grading, paving and/or other improvement of the Road shall be paid by the party which has the work done.

This Easement Location Agreement, and all provisions hereof, shall be binding upon, and shall inure to the benefit of, the Braaschs and MLS and their respective heirs, assigns, and successors in title.
