KNOW ALL MEN BY THESE PRESENTS:

That in consideration of LOVE & AFFECTION AND THE SUM OF TEN AND NO/100 (\$10.00) DOLLARS

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, Era Davis, the widow of Johnie A. Davis, deceased

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto Virginia Warren and Eileen Phillips

(herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Commence at the SW corner of the SE 1/4 of SW 1/4, Section 24, Township 21 South, Range 1 West; thence East along the Section line a distance of 21.0 feet to a point on the East side of an alley or street; thence N 3 deg. 30' W along said East side of an alley or street, a distance of 12.0 feet to an iron pipe in the ground that has been established as the Northwest corner of the Will W. Davis property; thence continue N 3 deg.30' West along said East side of an alley or street a distance of 60.0 feet to a point (iron pipe) at the present Northwest corner of the Johnie Davis lot to the point of beginning of the property herein conveyed; thence continue N 3 deg.30' W along the east side of said alley or street, a distance of 72.0 feet to an iron pin; thence N 70 deg.50' E a distance of 119.36 feet to an iron pin; thence S 3 deg. 30' E parallel to the East side of said alley or street, a distance of 72.0 feet to an iron pipe marking the present Northeast corner of the Johnie Davis lot; thence S 70 deg. 50' W a distance of 119.36 feet to the point of beginning. 
