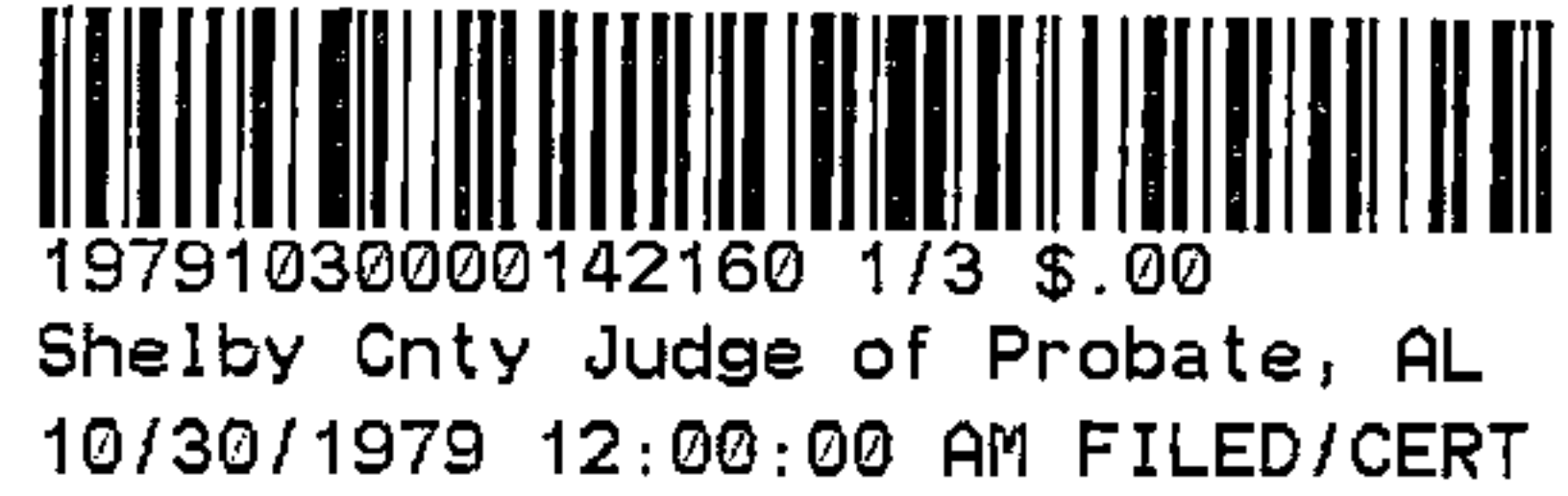

RESOLUTION



WHEREAS, a declaration signed by the owners of all of the lands abutting the hereinafter described street situated in the Town of Calera, County of Shelby, State of Alabama, vacating said street, has been duly presented to the Town Council of the Town of Calera, Alabama, for the assent and approval of said governing body, said declaration being hereto affixed, marked Exhibit "A", and made a part hereof, and

WHEREAS, the street above referred to is more particularly described as follows:

Lot No. 11 according to Baxley's Re-Survey of the Eastern Half of Word's Addition to Calera, said lot fronting on the East side of Word Street 24.0 feet, and

WHEREAS, it appears to the Town Council of the Town of Calera, Alabama, that the vacation of said street is in order and that convenient and reasonable means of ingress and egress is afforded to all other property owners owning properties in the subdivision embraced in said Baxley's Re-Survey of the Eastern Half of Word's Addition to the Town of Calera, Alabama;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CALERA, ALABAMA,

That the vacation of the hereinabove described street assented to and approved and the same are hereby vacated pursuant to the provisions of Section 23-4-20, Code of Alabama 1975.




