In consideration of the payment of cash in the amount of Twenty Thousand and No/100 Dollars (\$20,000.00), receipt of which is hereby acknowledged, James D. Davenport, President of Davenport Companies, Inc. (hereinafter called the "Assignor") hereby assigns to Joseph M. Briscoe, an individual, (hereinafter called the "Assignee") his successors and assigns, five percent (5%) of his right, title and interest as a partner of Riverchase Town Homes I, Ltd. (hereinafter referred to as the "Limited Partnership"). Effective October 1, 1979, the Assignee shall have the right to receive from the Limited Partnership the share of profits or other compensation to which the Assignor would have otherwise been entitled with respect to the said limited partnership interest and the right of return from the Limited Partnership of the contribution of the Assignor to the capital of the Limited Partnership with respect to said limited partnership interest.
