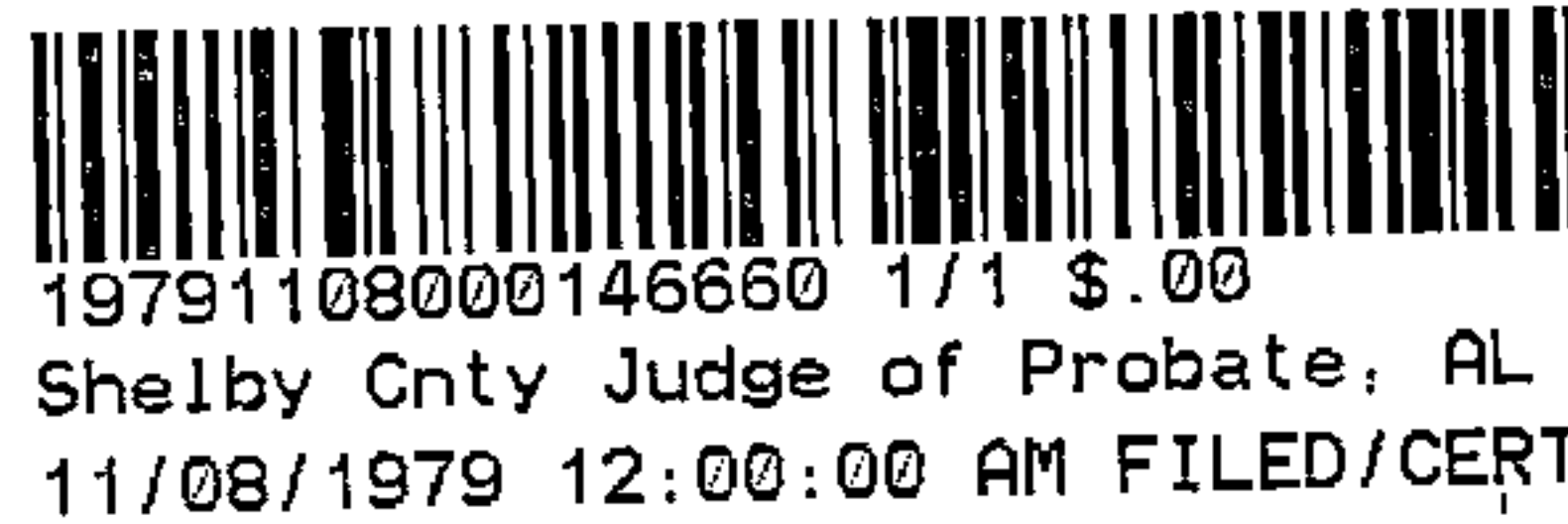


PARTIAL RELEASE

For and in consideration of One Dollar (\$1.00) and other good and valuable considerations to it in hand paid, the receipt whereof is hereby acknowledged, the undersigned FIRST ALABAMA BANK OF Birmingham, a corporation, does hereby release and discharge from the lien of that certain mortgage executed by C. Wayne Russell and Wife, Virginia B. Russell dated October 15, 1979 recorded in Volume 397, Page 539, Probate Records of Shelby County, Alabama; the following described property:

Begin at the Southeast corner of the Northwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of Section 13, Township 19 South, Range 2 West and run North along the Eastern line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 295.79 feet; thence turn an angle left $82^{\circ}16'30''$ and run Northwesterly a distance of 413.92 feet; thence turn an angle left $82^{\circ}56'30''$ and run southwesterly a distance of 60.67 feet; then turn an angle right $78^{\circ}37'$ and run northwesterly a distance of 111.82 feet; thence turn an angle left $35^{\circ}55'$ and run southwesterly a distance of 122.61 feet; thence turn an angle left $74^{\circ}10'$ and run southerly a distance of 253.30 feet; thence turn an angle left $87^{\circ}39'30''$ and run East along the South line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 661.63 feet to the point of beginning.
