the receipt of which is hereby acknowledged, the said Farris Land Company, Inc.

does by these presents, grant, bargain, sell and convey unto the said

Briarcliff Nursing Home, Inc.

the following described real estate, situated in Shelby County, Alabama

Commence at the Northeast corner of the West One-Half of the Southeast One-Quarter of the NW One-Quarter of Sec 35, Township 20 S, Range 3 West, run thence in a Southerly direction along the East line of said West One-Half of the SE One-Quarter of the NW One-Quarter of Sec 35, Twshp 20 S, Range 3 West, for a distance of 551.37 feet to the point of beginning.
