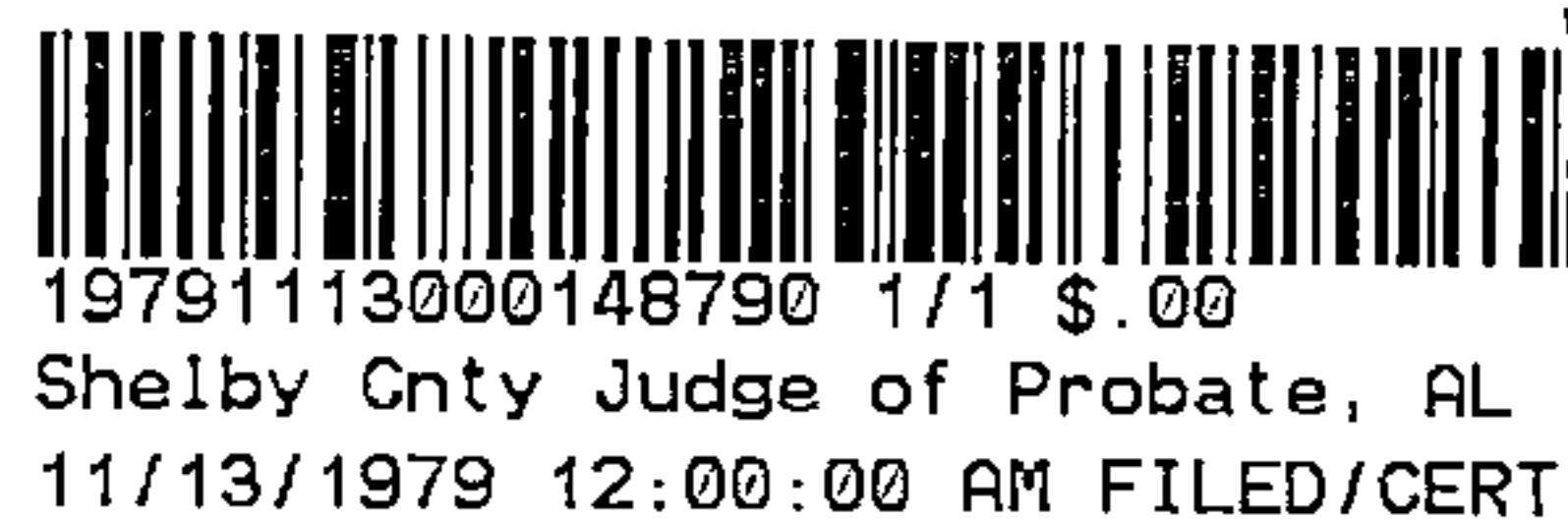

thence 89 deg. 35 min. left and southeasterly along said right of way line of 2nd Avenue for  
76.00 feet to the point of beginning.

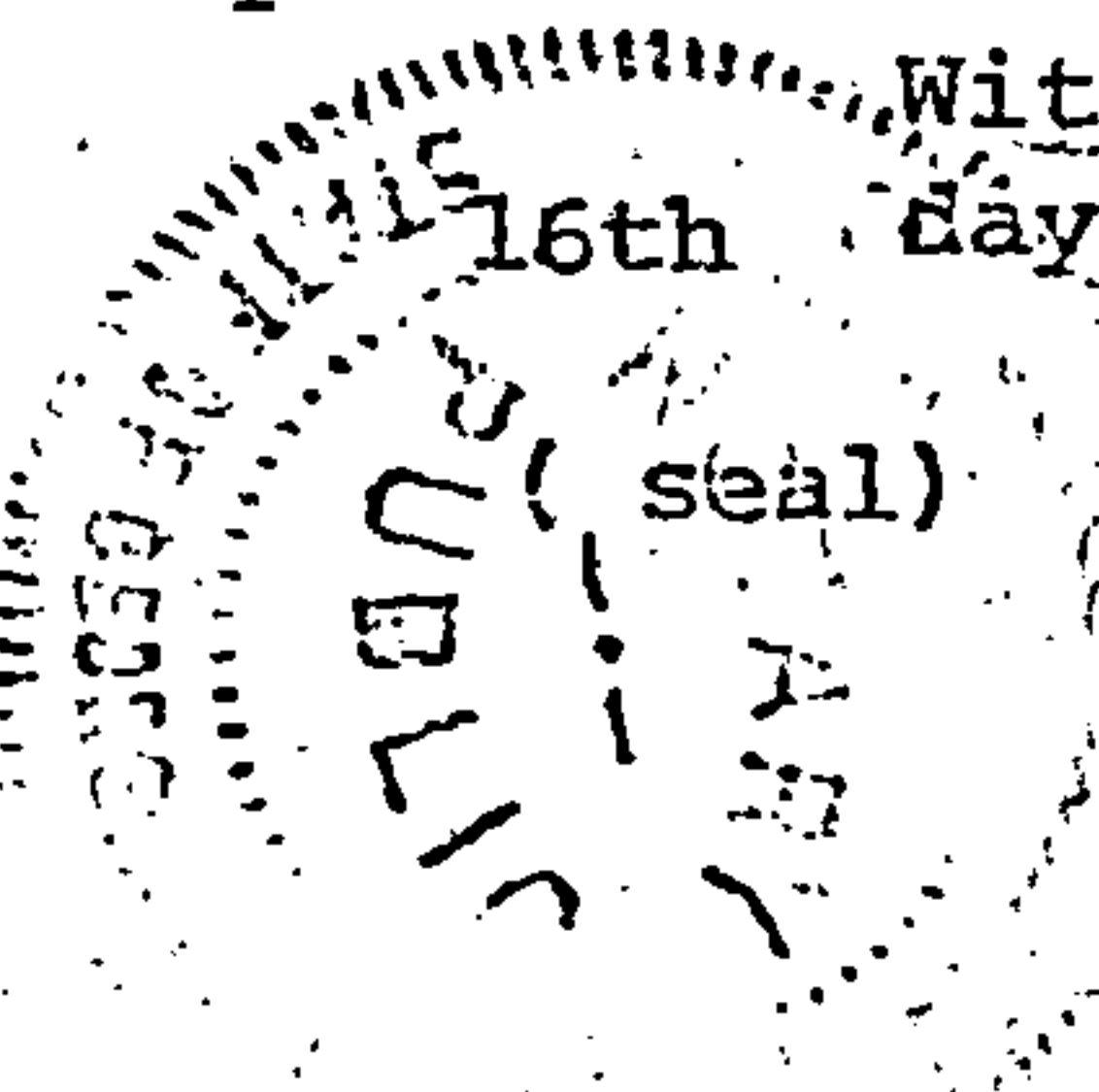
