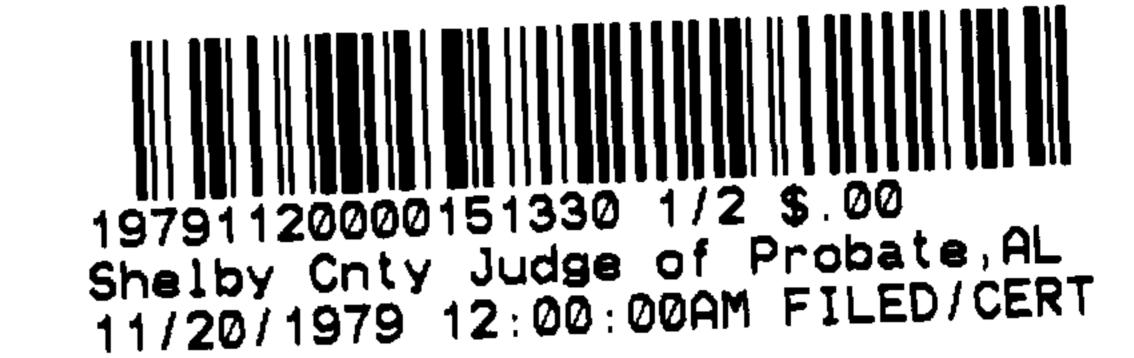

GENERAL WARRANTY DEED

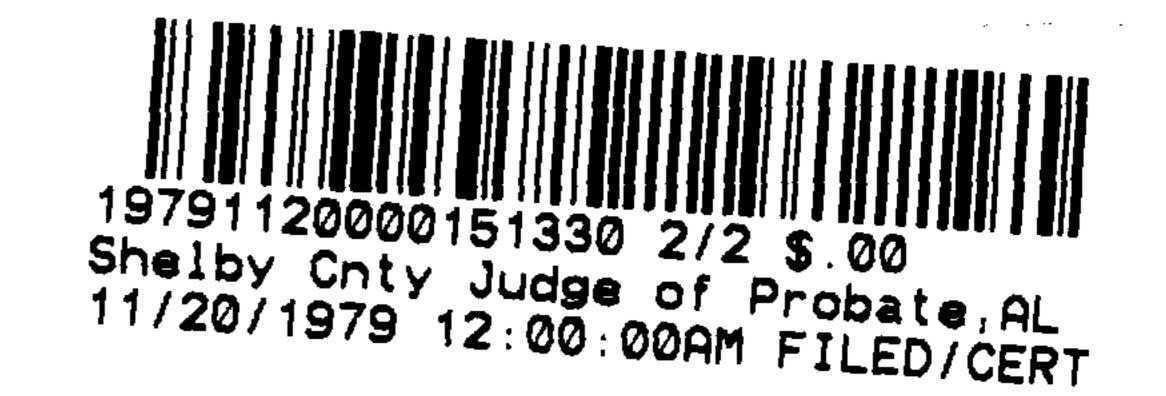
tion of Ninety-Four Thousand and No/00 Dollars (\$94,000.00) in hand paid to Country Development Corporation, an Alabama corporation (herein called the "Grantor"), by The Medical Clinic Board of the City of Pelham, Alabama, a public corporation under the laws of the State of Alabama (herein called the "Grantee"), the receipt and sufficiency whereof are hereby acknowledged, the Grantor does hereby grant, bargain, sell and convey unto the Grantee, its successors and assigns, the following described tract or parcel of land lying and being situated in the City of Pelham in Shelby County, Alabama, to-wit:

A parcel of land located in the Northwest Quarter of Section 25, Township 20 South, Range 3 West more particularly described as follows: Begin at the reference pin for the Southwest corner of the Northeast Quarter of the Northwest Quarter lying on the South Quarter line of said forty and run South 27 degrees 19 minutes West for 205.3 feet to the point of beginning; then run South 2 degrees 4 minutes West for 51.3 feet; then run South 75 degrees 30 minutes East for 190.6 feet; then run North 14 degrees 40 minutes East for 50 feet; then run North 75 degrees 30 minutes West for 201.9 feet, back to the point of beginning. The above said reference pin lies approximately 100 feet East of Highway 31 rightof-way under a cedar tree.
