
## MORTGAGE RELEASE

Now, therefore, the undersigned First National Bank of Childersburg in consideration of the newly executed mortgage by the said Olin Abbott and wife, Frankie Abbbott pollars, being paid to said First National Bank of Childersburg in hand paid by the said Olin Abbott and wife, Frankie Abbott the receipt whereof is hereby acknowledged, does hereby release, remise and quit claim unto the said Olin Abbott and wife, Frankie Abbott all the right, title and interest acquired under said mortgage in and to that part of the premises conveyed therein, and described as follows, to-wit:

Begin at the Southeast corner of the SE¼ of the NW¼ of Section 34, Township 19, Range 2 East, and run West along said Section line 226 feet, more or less, to the East right-of-way line of the Florida Short Route, sometimes known as U. S. Highway 91; thence run North-westerly along said highway right-of-way line 900 feet to the point of beginning of the lot herein described; thence run in a North-easterly direction, perpendicular to said highway right-of-way line 220 feet; thence run in a Northwesterly direction and parallel with said highway line 50 feet; thence run in a Southwesterly direction, and perpendicular to said highway line 220 feet to said highway right-of-way line; run thence in a Southeasterly direction along said highway right-of-way line 50 feet to the point of beginning; all being situated in SE¼ of NW¼ of Section 34, Township 19, Range 2 East, Shelby County, Alabama.

It is understood and agreed that this release shall not in any way impair or affect the right of the said mortgagee to hold the remainder of the premises conveyed in said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid on said mortgage.
