

Commence at the Northwest corner of the SE 1/4 of the SW 1/4 of Section 9, Township 18 South, Range 1 East, thence run Easterly along the North line for a distance of 45.0 feet, thence turn 54 deg. 27' to the right for a distance of 281.17 feet to the point of beginning.
