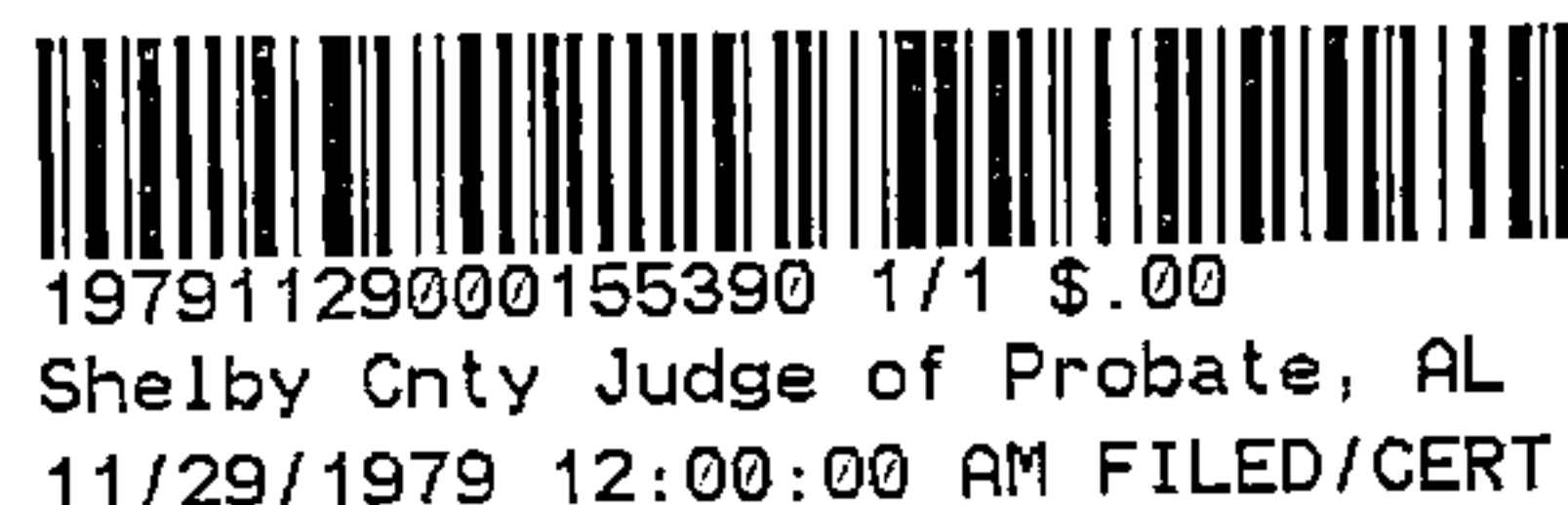


104 ASSIGNMENT OF MORTGAGE
