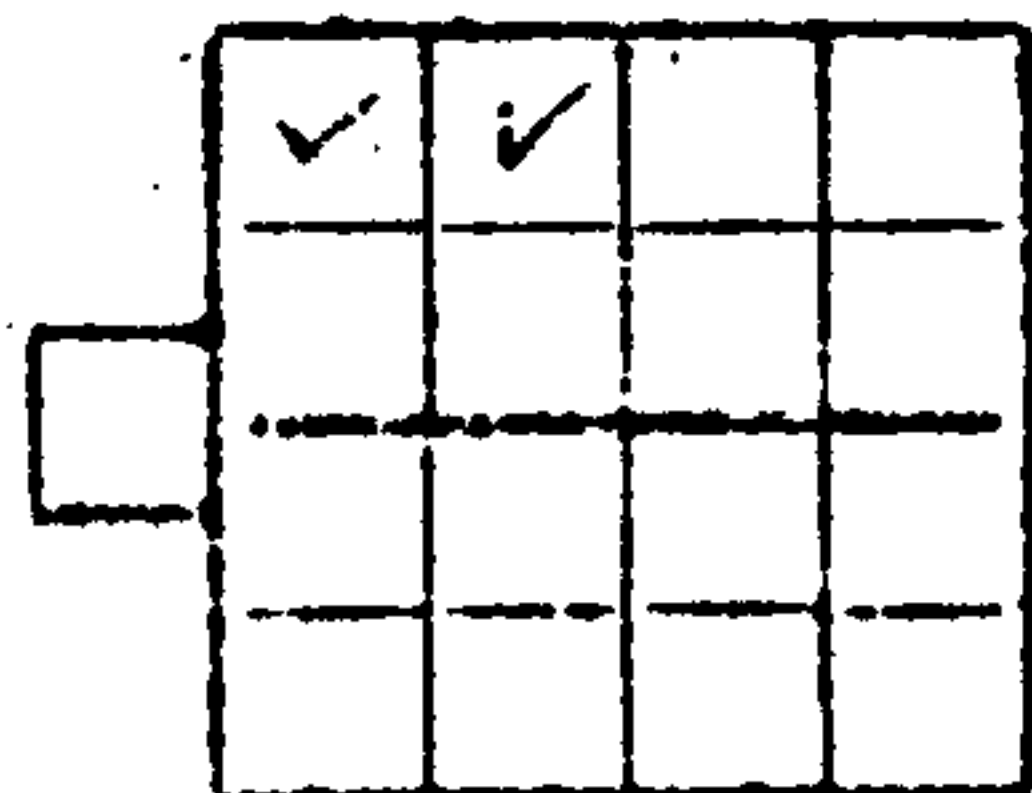
KNOW ALL MEN BY THESE PRESENTS, that the undersigned,

We, Elnora L. Denney and Husband, Thomas S. Denney

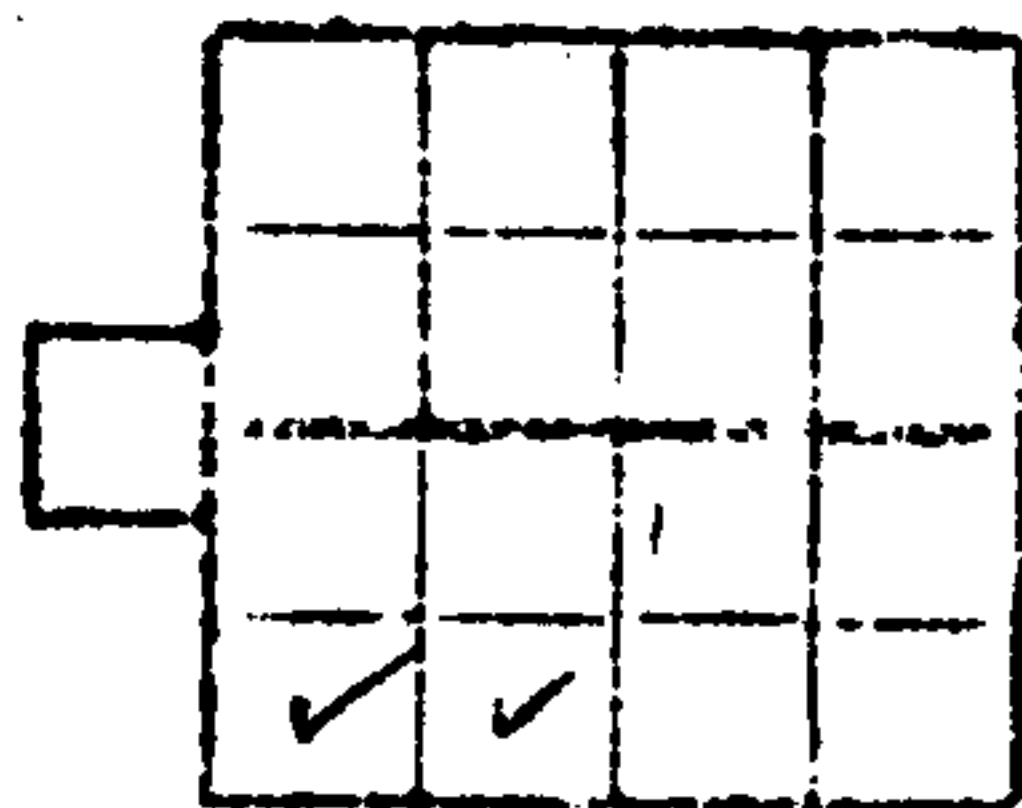
in consideration of the sum of One and No/100 Dollars (\$1.00), to US

duits, cables, trans closures and other appliances and facilities useful or necessary
in connection therewith for the overhead and underground transmission and distribu-
tion of electric power and for the overhead and underground communication service,
upon, over, under and across the following described land, situated in

Shelby County, Alabama:

All of the North $\frac{1}{2}$ of the NW $\frac{1}{4}$, Section 14, Township 20 South,
Range 1 West, lying North and West of the Columbiana to Chelsea
paved road; also all of the south $\frac{1}{2}$ of the SW $\frac{1}{4}$, Section 11,
Township 20 South, Range 1 West, lying west of said road, less
and except the north 370 feet of said SW $\frac{1}{4}$.





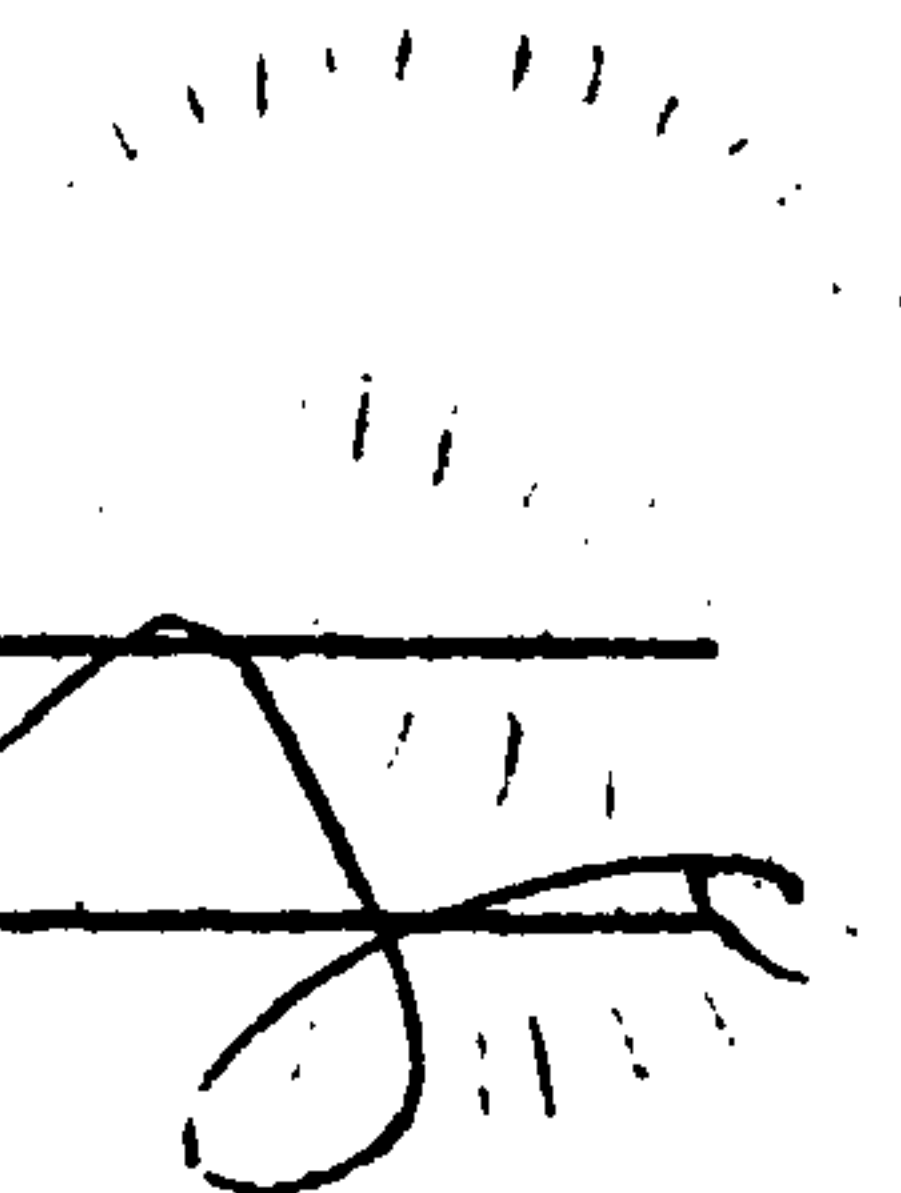
