WHEREAS, there was no conveyance of record to the said Moses Johnston, Thomas Walker, and Daniel Watrous but an abstract of title shows continuous: ownership for many years in other individuals, and

WHEREAS, The Board of Trustees of The University of Alabama has been advised by the Attorney General of Alabama that it has no right, title or interest in said property.
