DISCLAIMER OF INTEREST IN LAND

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, the United States of America reserved and vested in the Legislature of Alabama for a seminary of learning to be known as "The University of the State of Alabama" the W $\frac{1}{2}$ of Section 3 containing 250.80 acres in Township 24, Range 12, and the date of said grant is not of record, and

WHEREAS, The Legislature by Act of December 24, 1822, vested title to said land in The Board of Trustees of The University of Alabama, who subsequently sold to Moses Johnston, Thomas Walker, and Daniel Watrous the W $\frac{1}{2}$ of Section 3, Township 24 North, Range 12 East, Shelby County, Alabama under date of June 9, 1830, and

WHEREAS, there was no conveyance of record to the said Moses Johnston, Thomas Walker, and Daniel Watrous but an abstract of title shows continuous ownership for many years in other individuals, and

WHEREAS, The Board of Trustees of The University of Alabama has been advised by the Attorney General of Alabama that it has no right, title or interest in said property.

NOW, THEREFORE, in consideration of the premises, The Board of Trustees of The University of Alabama, upon recommendation of the Attorney General of Alabama, does hereby expressly disclaim any right, title, interest or claim in and to the following described real estate, to-wit:

The W $\frac{1}{2}$ of Section 3, Township 24 North, Range 12 East, Shelby County, Alabama.

IN WITNESS WHEREOF, The Board of Trustees of The University of Alabama has caused this Disclaimer of Interest in Land to be executed in its name by its duly authorized Executive Committee and its corporate seal to be affixed on this 22 day of June, 1979.
