KNOW ALL MEN BY THESE PRESENTS.

That in consideration of Forty-Nine Thousand Five Hundred and 00/100 Dollars (\$49,500.00)

to the undersigned grantor, Birmingham Trust National Bank, a national banking association, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto

Scott A. Griffith & wife, Janet Leah Griffith

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 2, according to the survey of Brandywine, Second Sector, as recorded in Map Book 7, Page 6, in the Probate Office of Shelby County, Alabama.

This conveyance is subject to the following:

1. Taxes due in the year 1980 which are a lien but not due and payable until October 1, 1980.
2. 40' Building line as shown by recorded map.
3. Easement on center of lot & 10' easement on west side as shown by recorded map.
4. Right of way to Alabama Power Company recorded in Volume 309, Page 394, in the Probate Office of Shelby County, Alabama.
5. Restrictions recorded in Miscellaneous Volume 21, Page 759, in said Probate Office.
6. Statutory right of redemption evidenced by foreclosure deed recorded in Volume 321, Page 148 in said Probate Office.
