Before me a Notary Public in and for Shelby County, Alabama, personally appeared Lorene Harkins Hinds, who is known to me and who being by me first duly sworn, deposes and says on oath as follows:

My name is Lorene Harkins Hinds. I am 65 years of age and my residence address is at Helena, Shelby County, Alabama.

I am the widow of George Hinds, Deceased, who was a son of Charles I. Hinds, Deceased.

I have recently made an affidavit relative to the Hinds family on August 28, 1979, my said affidavit having been recorded in Miscellaneous Book 32 at pages 838, -839, Office of Judge of Probate of Shelby County, Alabama, and I have just discovered that said affidavit contains a mistake on the second page relative to the children of George Hinds and me.

The facts are that my late husband, George Hinds, and I had six children-- five girls and one boy--rather than five children, as is stated in my former affidavit.

I first discovered the error in the draft copy of the affidavit as prepared by the attorney before I signed the first affidavit, and I thought that said affidavit had been corrected to designate all six of my children, but I did not discover that said affidavit had not been corrected until a few days ago.

The true and correct facts are that my said husband, George Hinds, died more than two years ago while a resident of Shelby County, Alabama, without a Will, leaving myself as his surviving widow. Said George Hinds had only six children ever born of him, namely, Louise Hinds Bartlett, Billy G. Hinds, Janice Hinds Johnston, Sue Hinds Acton, Pam Hinds (who was formerly Pam Hinds Roland but who has now divorced and has reassumed her former name of "Pam Hinds"), and Patricia Ann Parrish, all of who are of sound mind and over nineteen years of age. Said George Hinds is not survived by any other children or descendants of deceased children.

I have re-read my former affidavit which is recorded in Miscellaneous Book 32 at pages 838 and 839, Office of Judge of Probate of Shelby County, Alabama, and I hereby re-affirm that said affidavit is true and accurate,
