

## AGREEMENT

ENOW ALL MEN BY THESE PRESENTS that in consideration of One Dollar and other good and valuable consideration paid by the City of Pelham to W. M. Humphries Enterprises, Inc., the receipt and sufficiency of which is hereby acknowledged by the Grantor, W. M. Humphries Enterprises, Inc. it is agreed as follows;

The City of Pelham may install at its expense a sanitary sewer line from certain property it has purchased for use as a firestation and for no other use more particularly described as set out in Exhibit "A" along a strip of land owned by the Grantor herein more particularly set out in Exhibit "B", to connect with the present sanitary sewer system operated in that certain mobile home park known as Greenpark South Mobile Home Park owned by the Grantor herein. In addition, the City of Pelham shall have the right to use the sanitary sewer facilities for Greenpark South Mobile Home Park upon payment of a minimum sewage charge to the owner of said sanitary sewer facilities. This right granted to the City of Pelham shall continue so long as the sanitary sewer facilities are maintained and operated provided however that in the event active public sewer becomes available within fifty (50) feet of the property described as Exhibit "A", the City of Pelham shall have ninety (90) days to connect to the active public sewage. Mothing in this grant shall require W. M. Humphries Enterprises, Inc., it successors and assigns, to continue the sanitary sewer facilities if problems develope with the treatment plant or economics dictate that the facilities should not be continued.
