TO HAVE AND TO HOLD unto the said Metropolitan Life Insurance Company its successors and assigns, FOREVER.

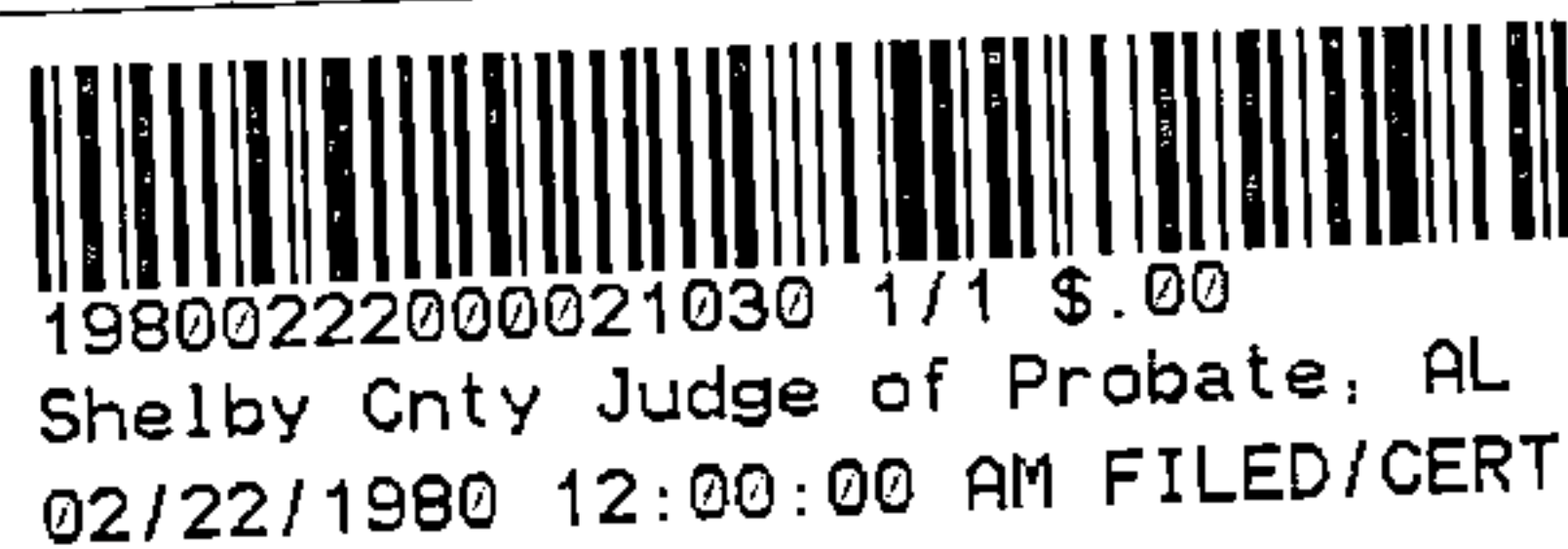
