My name is Frank W. Wheeler. I am a Land Surveyor, registered by the State of Alabama, and my residence address is Route 1, Wilsonville, Alabama 35186.

I have been asked to make this affidavit to clarify a typographical error contained in that certain deed from Byron B. Barnes and wife, Louise Barnes to James Breckenridge Barnes dated January 26, 1978, recorded in Deed Book 310 at page 164, Office of Judge of Probate of Shelby County, Alabama.

I made the original land survey of said property which was conveyed to said James Breckenridge Barnes by said deed, a copy of my plat of said survey being attached hereto as Exhibit "A" and by reference hereto being made a part hereof.

Said parcel which was conveyed to said James Breckenridge Barnes by said deed is actually situated in the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 10, Township 21 South, Range 1 East, as is shown by said plat which is attached hereto as Exhibit "A" and as stated in the last sentence in the property description contained in said deed which is recorded in Deed Book 310 at page 164 in said Probate Office. The first sentence in the property description in said deed to James Breckenridge Barnes contained a typographical error in that the commencement point is stated as being at the northwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$, Section 21, Township 21 South, Range 1 East, whereas the commencement point should have correctly been stated as being at the northwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$, Section 10, Township 21 South, Range 1 East.

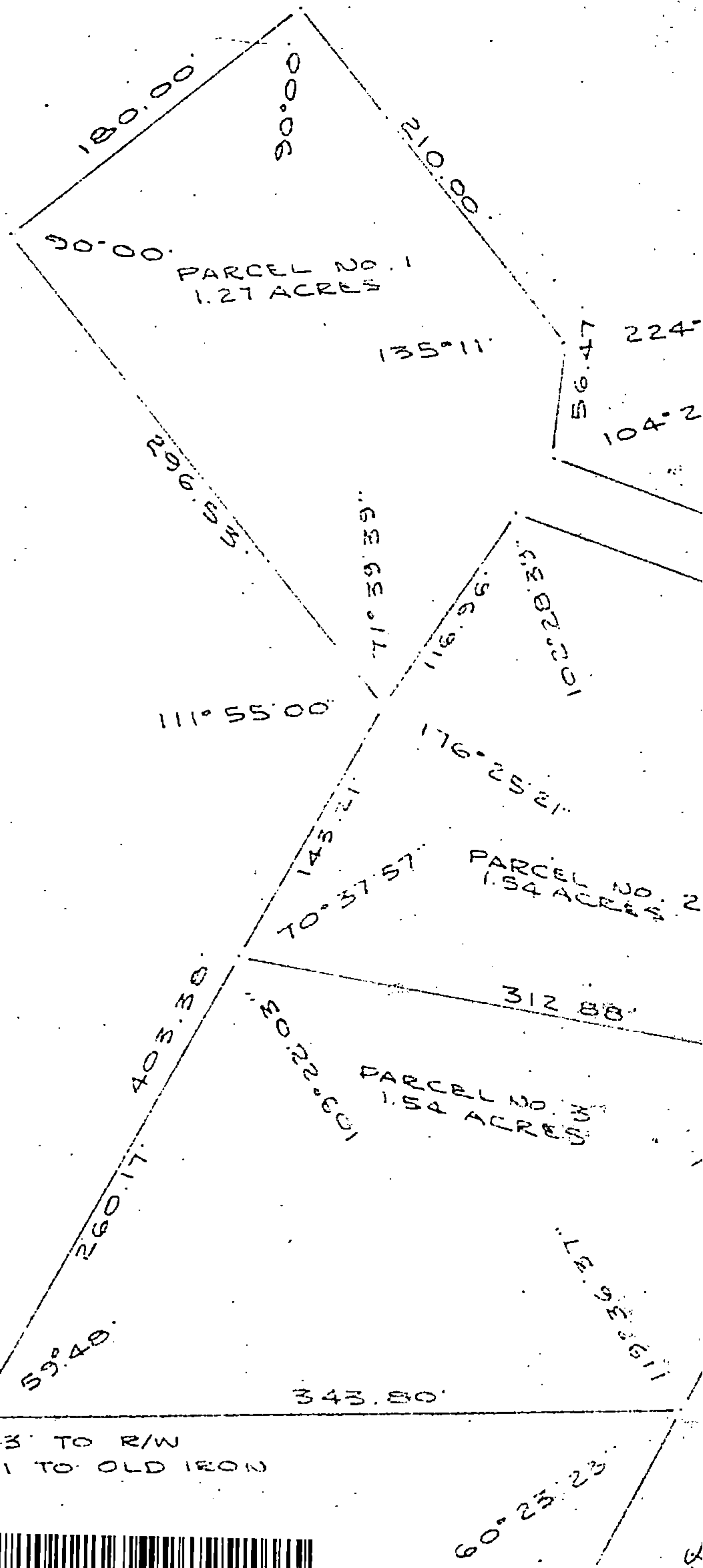

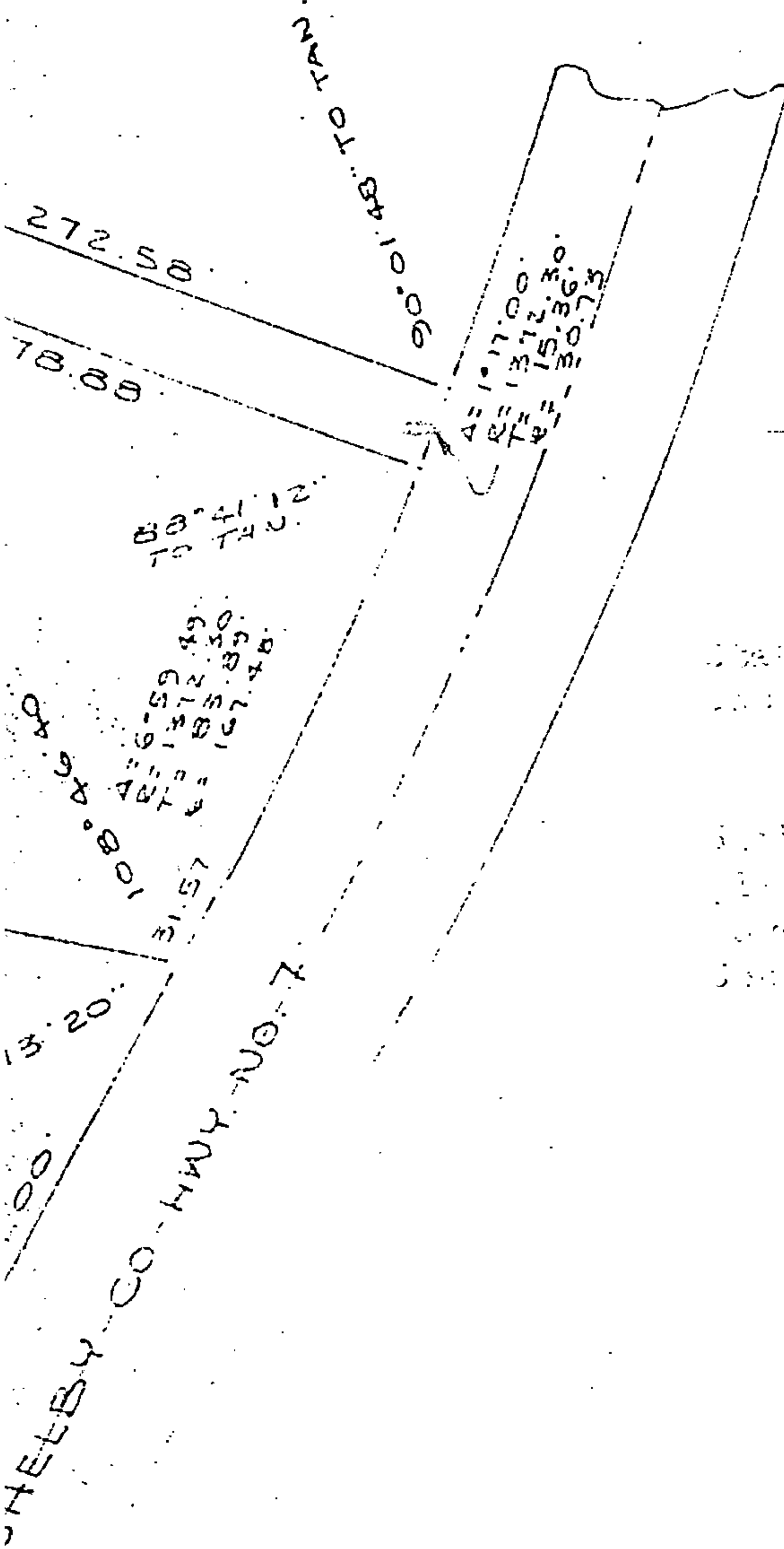
