KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One Thousand Dollars (\$1,000.00) and other good and valuable considerations to the undersigned Grantor, The Alabama Mineral Land Company, a corporation, in hand paid by Alabama Property Company, a corporation, the receipt whereof is hereby acknowledged, said The Alabama Mineral Land Company does by these presents, grant, bargain, sell and convey, unto said Alabama Property Company (a) mineral and mining rights in and to the lands described in Exhibit "A" attached hereto and made a part hereof by reference as though fully set out herein, (b) all surface mining rights as may be owned by Grantor herein in connection with such lands described in Exhibit "A", (c) all other rights necessary or useful in connection with the mining and removal of all minerals from such lands described in Exhibit "A" as may be owned by Grantor herein, and (d) all easements, rights of way, haulageways and other rights or titles which Grantor herein may have or own in and to the surface of such lands or portions thereof, all of which said lands are situated in the following counties: (1) Autauga, (2) Bibb, (3) Calhoun, (4) Clay, (5) Cleburne, (6) Cherokee, (7) Chilton, (8) Coosa, (9) Dallas, (10) Etowah, (11) Perry, (12) Randolph, (13) Shelby, (14) St. Clair, and (15) Talladega.

No purchase money vendor's lien is retained by Grantor herein.

It is the intent of Grantor herein to convey to Grantee, and Grantor does hereby convey to Grantee, all mineral rights owned by Grantor (except in situations where Grantor herein also owns full surface interests), except the mineral rights which Grantor herein has concurrently herewith conveyed to Southern Electric Generating Company, as described on Page 26 of Exhibit "A" attached hereto. By execution and delivery of the within deed to Grantee, Grantor conveys to Grantee all such other mineral rights as may be owned by Grantor as of the date of the execution of the within conveyance, but which are not described in Exhibit "A" attached hereto, with the exceptions hereinabove noted.

This deed is executed in consummation of a sales agreement entered between the parties herein on January 25, 1972; however, the duties of the parties set out therein, as to which performance has not been completed on the date of this deed, shall survive this closing and shall be effective in the future to require timely performance by the party obligated by such sales agreement even though such obligations are not again set out in this deed. No lien of any type exists in Grantor, or any other party, because the total purchase price may not have been paid by Grantee to Grantor upon the execution of this deed.

AND said The Alabama Mineral Land Company does for itself and for its successors and assigns covenant with the said Alabama Property Company, its successors and assigns, that it is the legal owner of mineral and mining rights in and to the lands described in Exhibit "A" attached hereto and which are being conveyed herein to Grantee, that they are free from all encumbrances, with the exception of the long-term lease from Grantor to Riverside Clay Company, dated December 17, 1968, and except state, county and city ad valorem taxes for the tax year 1973, due and payable October 1, 1973, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same unto Alabama Property Company, its successors and assigns forever against the lawful claims of all persons, except, however, any provision in this entire conveyance to the contrary notwithstanding, for the breach of any warranty made by Grantor herein, either express or implied, by operation of law or otherwise, the total liability of Grantor, and its successors and assigns, to Grantee and its successors and assigns, under any of the provisions hereof shall be limited and restricted solely to the maximum sum of Twenty-Five Cents (\$.25) per acre for each acre of which Grantor may not be the legal owner, or which may be encumbered by any lien or other impediment not herein specifically excepted which may prevent or hinder Grantee, and its successors and assigns, from exercising effectively the rights and privileges herein conveyed by Grantor to Grantee.
