KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of TWENTY-ONE THOUSAND FIVE HUNDRED AND 00/100THS DOLLARS (\$21,500.00) in hand paid by NATTER PROPERTIES, INC., hereinafter referred to as "GRANTEE"), to the undersigned, THE HARBERT-EQUITABLE JOINT VENTURE, under Joint Venture Agreement dated January 30, 1974 composed of Harbert Construction Corporation, a corporation, and The Equitable Life Assurance Society of the United States, a corporation (hereinafter referred to as "GRANTOR"), the receipt of which is hereby acknowledged, the said GRANTOR does by these presents grant, bargain, sell and convey unto the said GRANTEE the following described real estate situated in Shelby County, Alabama:

Lot 25-A, according to Resurvey of Lots 24 and 25, Third Addition, Riverchase Country Club Residential Subdivision, as recorded in Map Book 7, Page 146, in the Office of the Judge of Probate of Shelby County, Alabama.

Such land is conveyed subject to the following:

1. Ad valorem taxes due and payable October 1, 1980.
2. Mineral and mining rights not owned by GRANTOR.
3. Any applicable zoning ordinances.
4. Easements, rights of way, reservations, agreements, restrictions and setback lines of record.
5. 


