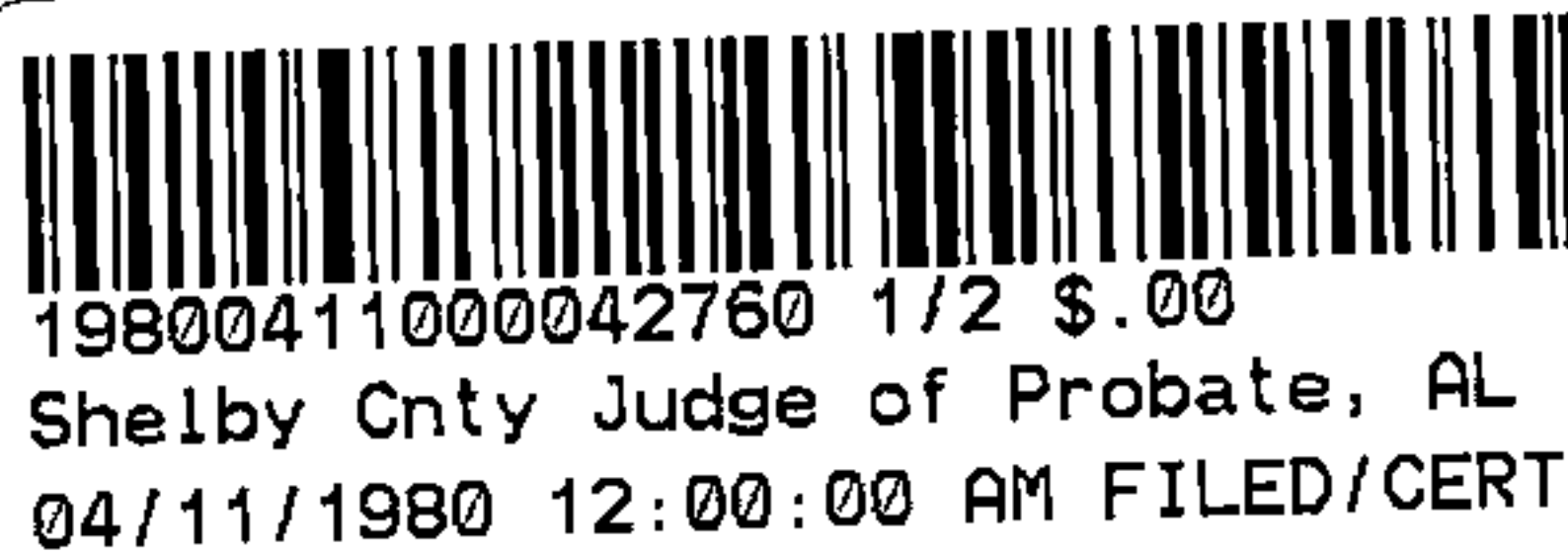

I, JAMES MARVIN Mc MILLIAN SR, in said County of said State, do make this my last will and testament, as follows:

FIRST: I direct that all of my just debts be paid as soon after my death as convenient;

SECOND: I will and bequeath all of my estate, whether real or personal or of any nature whatsoever (this meaning to include life insurance benefits, bank deposits, any interest or claim. I may, at time of my death, have in any stocks, bonds, or other securities or investments of any kind, real estate, household goods, or effects, jewelry, and any monies other than bank deposits or not otherwise specified) to Edna Thomas McMillian, my wife, to hold unto her own use throughout her natural life or to sell or otherwise dispose of as she may see fit;

THIRD: I hereby appoint Edna Thomas McMillian to be Executrix of this my last will and testament, and direct that she shall not be required to make any inventory nor give bond, nor shall she be required to make any reports or settlements, final or otherwise, in or to any Court;

FOURTH: I hereby authorize and empower my said Executrix to sell all or any part of my estate, real or personal, in such order and in such manner as she may see fit, for the purpose of paying any debts or for any other purpose which, in her judgment, may be required.

IN TESTIMONY WHEREOF, I hereunto set my hand and seal this 10th day of January, 1955.

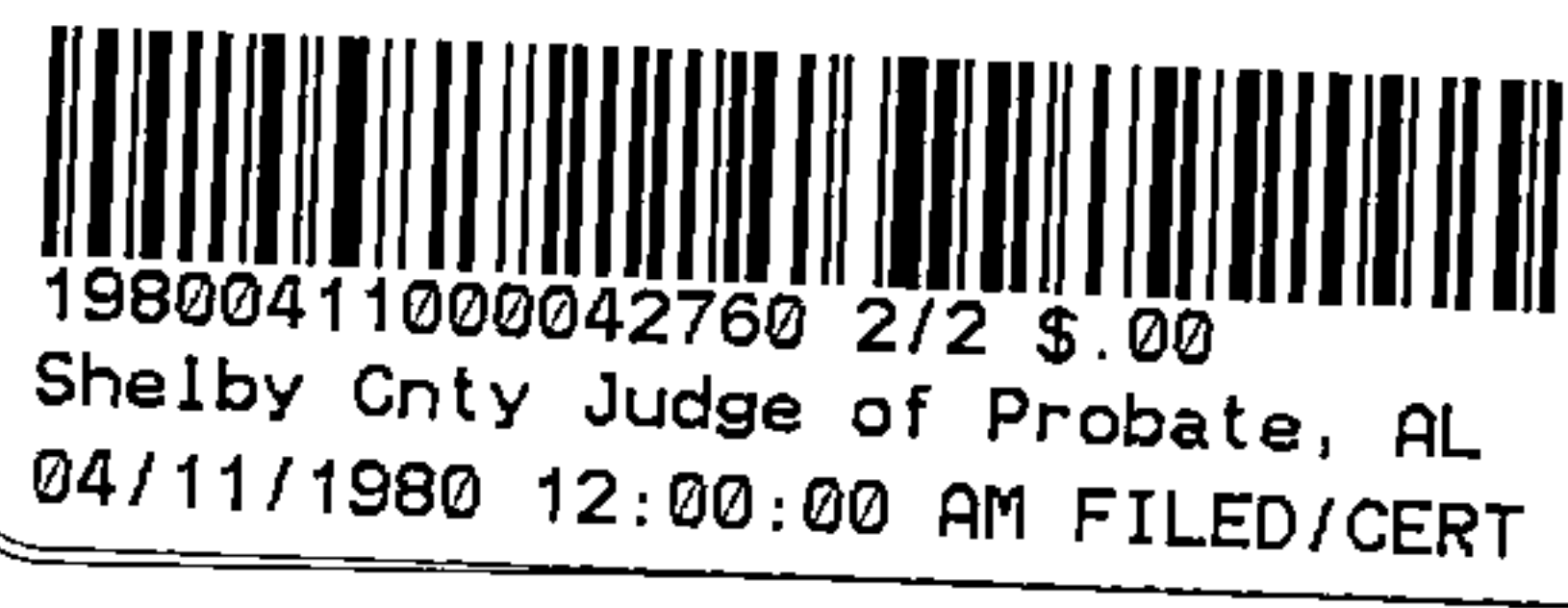
