ARTICLE ONE

NAME

The name of the Corporation is Gobblers'Knob Swim and Tennis Club, Inc.

ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual.

ARTICLE THREE

Objects and Purposes

Objects and purposes of this corporation shall be to maintain a private, social and athletic association: to establish and maintain facilities for social and recreational activities of the members of the corporation and such other persons as the Directors of the corporation may select; to construct, maintain, improve and beautify certain real estate to be owned by the corporation for the purposes of a swimming pool, tennis courts or courts of other types and other recreational facilities consistent therewith; to solicit, receive, hold and maintain funds and to make use of said funds as the Directors may direct in order to carry out the objects and purposes of the corporation; and in the accomplishment of any of the purposes herein stated.
