
PARTIAL RELEASE

all of the right, title and interest of the undersigned in and to the following

described property in Shelby County, Alabama, to-wit:
A part of the SW4 of the SE4 of Section 9, Township 24 North, Range 14 East, more particularly described as follows: Begin at the Southeast corner of said quarter-quarter section and run thence in a Northern direction along the Eastern boundary of said quarter-quarter section a distance of 210 feet, more or less, to a point on the Southern boundary of Buxahatchee Creek; thence turn to the left and run Westerly and Southwesterly a distance of 210 feet, more or less, along the Southern low water mark of Buxahatchee Creek to a point where the same intersects the low water mark of the Eastern bank of Hurricane Branch; thence run Southerly along the Eastern low water mark of Hurricane Branch a distance of 210 feet, more or less, to a point where the same intersects the Southern boundary of said quarter-quarter section; thence turn to the left and run Easterly along the Southern boundary of said quarter-quarter section a distance of 210 feet, more or less, to the point of beginning.

But it is expressly understood and agreed that this release shall in no wise, and to no extent whatever, affect the lien of said mortgage as to the remainder of the property described in and secured by said mortgage.
