satisfaction of said mortgage, hereby ratifying and confirming the acts done by the attorney-in-fact hereunder.

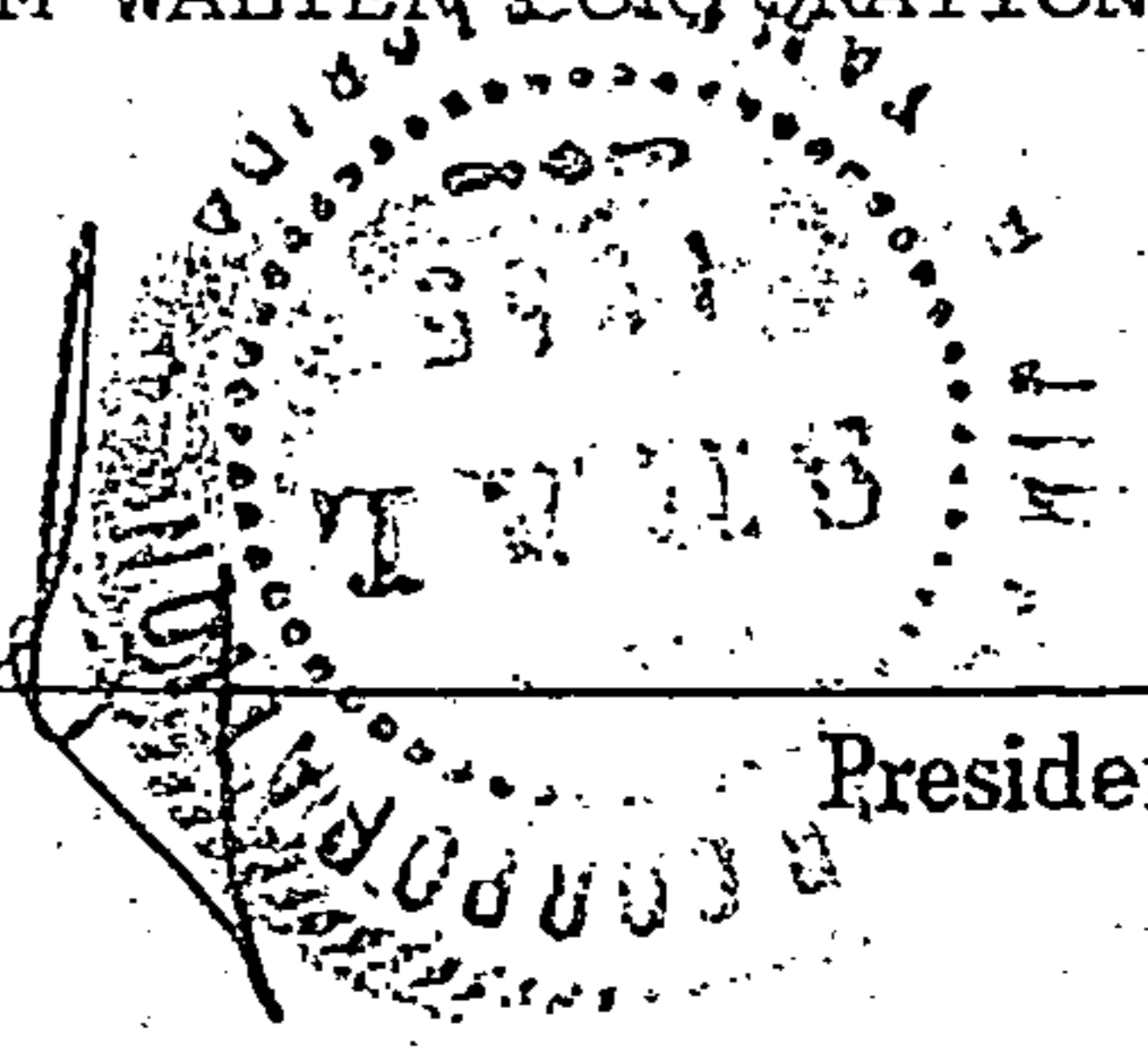
