DECLARATION OF CLAIM OF EXEMPTION

IN THE PROBATE COURT OF SHELBY COUNTY, ALABAMA.

That he is over the age of 21 years and is a bona fide resident of the City of Alabaster, County of Shelby, State of Alabama, and that he owns and actually resides on as his homestead, the following described real estate situated in the city of Alabaster, county of Shelby, State of Alabama:

Lot 4, Block 3, according to Map of Navajo Hills, Sector Two, as recorded in the Probate Office of Shelby County, Alabama, in Map Book 5, Page 24.

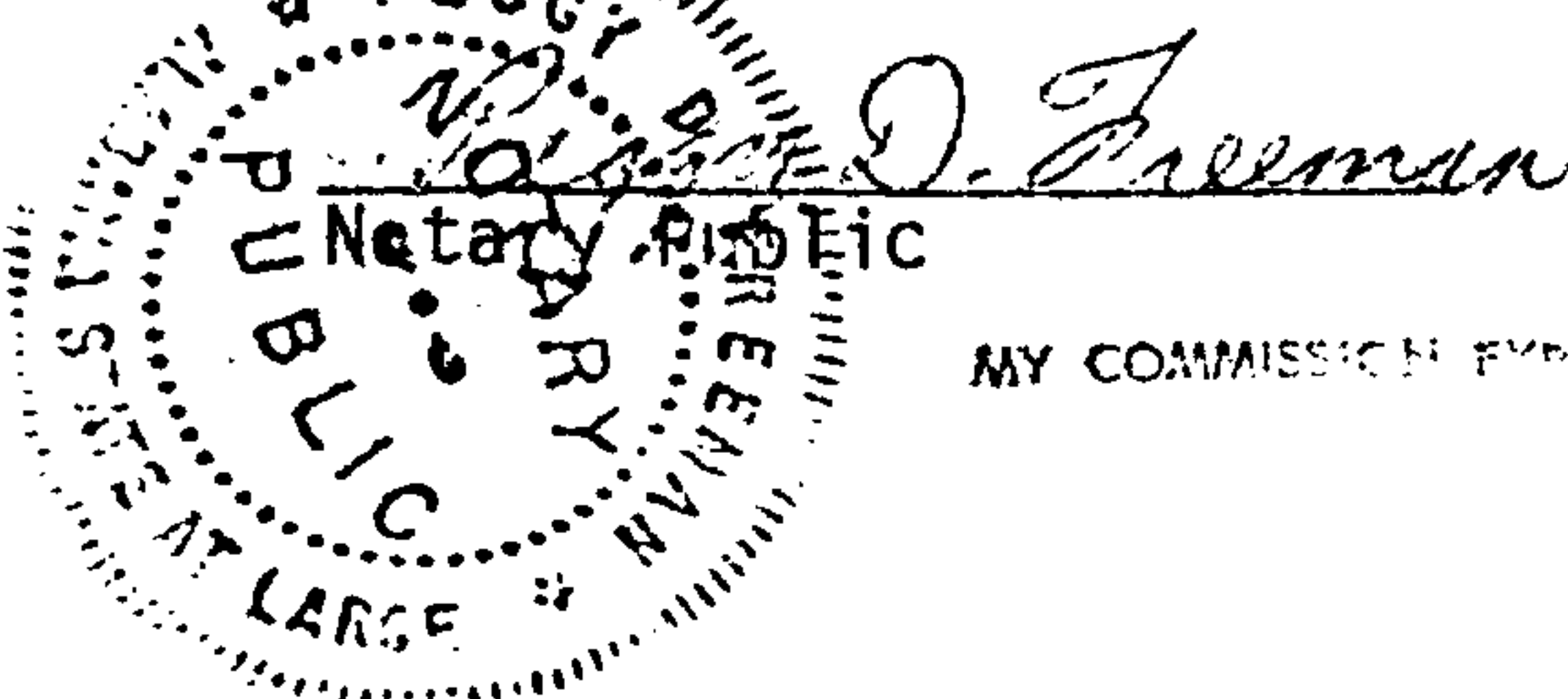
