W I T N E S S E T H:

In Consideration of the Sum of One Dollar (\$1.00) and to correct and replace that certain indenture made and entered into on January 14, 1974, by and between the Grantors granting the easement described below, the Grantors have this date bargained and conveyed and by these presents do hereby grant and convey unto the Grantee, an easement for a road, in, to, along, over, through, and across the hereinafter described land, to-wit:

A fifty (50) foot easement for a right of way lying twenty-five (25) feet on each side of the following described line, to-wit:

Beginning at the NW corner of the SE 1/4 of the SW 1/4, Section 14, Township 18, Range 1 East, thence South for a distance of 559 feet to the point of beginning; from said point of beginning thus obtained, turn left at an angle of 88 degrees East of North for a distance of 270 feet; thence turning right an angle of 99 degrees for a distance of approximately 200 feet to a point of intersection of the North-South line of property of Donald and Marilyn Prier.

ALSO: A fifty (50) foot strip of land for said right of way commencing at the termination of the above described easement and running parallel to the west line of the William D. Prier and wife, Marilyn S. Prier property and continuing to the SW corner of said William D. Prier and wife, Marilyn S. Prier property; thence continue said 50 foot strip South for 50 feet along the west line of the Harold C. Grigsby and wife, Carol A. Grigsby property.
